Senator Cwodzinski moved that S.F. 4553, be laid over for possible inclusion in the omnibus bill. - **MOTION PREVAILED.**


S.F. 4305: Senator Kupec: Roof projects as part of the long-term education facilities maintenance program authorization and appropriation.

Senator Kupec presented S.F. 4305.


