Bill Description

This bill requires MDE to develop and implement statewide academic standards in health.

Assumptions

Development of statewide Academic Standards in Health would begin in 2024-25 school year.

Creating statewide Health standards would exceed MDE's current capacity. It would be necessary to hire one full-time Education Specialist 2 beginning in FY25 to coordinate the standards development process as well as lead statewide implementation support efforts for the standards.

For the Standards Committee required under 120B.021, MDE will be responsible for the cost of the 30 substitutes at \$220 per day for 10 committee days. As for the daily meeting expenses for these 30 participants, the fiscal note assumes that 25 of them will live within the metro area and have roundtrip mileage costs of 40 miles while the remaining five participants will live outside of the metro area and have roundtrip mileage costs of 250 miles. MDE assumes that all 30 participants will be reimbursed at the standard business rate of \$0.67 per mile. The 25 metro participants will be reimbursed for one lunch at \$13. The five outstate members will be reimbursed for one dinner at \$19, one breakfast at \$11, one lunch at \$13 and one hotel night at \$150. Two of the outstate members will have child care costs of \$40. This is a total of \$28,850 in meeting expenses for the 10 meetings. In addition, 5 expert reviewers will be needed to review the standards at a cost of \$5.000 each.

The rulemaking to add health education standards to the curriculum is considered a small rulemaking under chapter 14. For staffing costs, it is assumed that MDE will only require some clerical support. Therefore, the total \$11,935 rulemaking cost split between FY25 and FY26 includes the clerical support, the administrative hearings portion of rulemaking (i.e. legal feels, admin law judge costs, and filing fees), the State Register costs (i.e. request for comments, notice of intent, and notice of adoptions), and other miscellaneous costs (i.e. mailing, duplication, and transcripts).

Bill Description

SF3746-1E authorizes the Department of Education (Department) to conduct rulemaking to adopt statewide academic standards in health and health education.

Assumptions

The Office of Administrative Hearings (OAH) in consultation with Minnesota Management and Budget (MMB) assesses agencies the cost of services rendered to them. All agencies shall include in their budgets provisions for such assessments.

OAH has used the Department's assumption that a small rulemaking will be required to meet the requirements of Section 4, (120B.021, Subd. 3) 'Rulemaking' and Section 7, 'Health Education Standards'. Based on past practices, OAH assumes that a small rulemaking under chapter 14 will require an estimated 10 hours of administrative law judge (ALJ) time for activity related to rulemaking procedures. Of the total rulemaking amount estimated by the Department, \$2,450 is for the 10 hours of ALJ time for rulemaking.

OAH currently bills ALJ time for rulemaking at the MMB-approved billable rate of \$245 per hour (see Minn. Stat. § 16A.126, subd. 1 (2022)).

Expenditure and/or Revenue Formula

Estimated 10 hours of ALJ time for rulemaking activities related to implementing the requirements of Sec. 4 and Sec. 7, = 10 hours x \$245/hr = \$2,450 charged to the Department in FY2026 pursuant to the requirements of Minn. Stat. § 14.53.

Long-Term Fiscal Considerations

Costs associated with rulemaking activities are a one-time occurrence.
