HF 3606 relating to professional licensing; requiring the Board of Architecture, Engineering, Land Surveying, Landscape Architecture, Geoscience, and Interior Design to provide notice by email to license and certificate holders whose license or certificate is about to expire; amending Minnesota Statutes 2022, section 326.10, subdivision 8.

Assumptions

Implementation and ongoing support of the law will require changes to the Board's online renewal system, licensing database and initial on-line applications.

The online renewal system does not and never has required licensees or certificate holders to provide this piece of private data (email address) for purposes of renewal notification so notice will need to be provided to licensees.
