S.F. No. 885 – Provisions modification relating to the Board of Barber Examiners – as proposed to be amended by the A-2 amendment.

Section 1 [Fees; 154.003] adds fees for registration of a mobile barber shop and for renewal and restoration of a mobile barber shop registration. Also specifies that an examinee must pay a third-party examination provider for the comprehensive examination if the board uses a third-party examination provider. The amount the examinee must pay for the examination is not specified or capped.

Section 2 [Registration Mandatory; 154.01] are technical changes and changes to conform with the addition of a mobile barber registration.

Section 3 [Certificate of registration; 154.02, subd. 4] makes technical changes and conforming changes related to mobile barbering.

Section 4 [Designated registered barber; 154.02, subd. 5] makes conforming changes related to mobile barbering.

Section 5 [Mobile barber shop; 154.02, subd. 7] defines "mobile barber shop." A mobile barber shop is a barber shop operated in a mobile vehicle or a mobile structure for the exclusive use of practicing barbering services by a registered barber.

Section 6 [Mobile Barber Shops; 154.052] establishes a new registration for mobile barbers.

Subd. 1. [Registration] precludes operation of a mobile barber shop unless the shop is under the direct supervision and management of a registered barber and registered.

Subd. 2 [Services and location reporting requirements] limits the services that may be provided in a mobile barber shop to hair cutting and straight razor shave services. Makes a mobile barber shop subject to the same shop rules as other barber shops, except where rules conflict with specific mobile barber shop requirements. Specifies that a reference to "barber shop" in law or rules includes "mobile barber shops" except where law or rules conflict with

specific mobile barber shop requirements. Specifies requirements for a mobile barber shop registration. The registrant must maintain a permanent address to receive correspondence and service of process and must provide an address where the mobile barber shop is kept when not in service. The registrant must display the name of the shop and the shop's registration number on an exterior side of the shop. The registrant must provide the board with specified vehicle identification and license plate information. A registration applies to only one mobile shop or structure. A registrant must have a functioning phone available at all times. The registrant must submit to the board on the 1st of each month a schedule of locations and times of operation for the month and must report changes to the board by email at the beginning of each week. Requires a registrant to comply with all laws and ordinances.

Subd. 3 [Water and wastewater requirements] requires a mobile shop to have selfcontained water holding tanks with gauges that indicate tank levels and reserve capacity. The tanks must be integrated and plumbed into the wastewater tanks or gray water tanks. A mobile barber shop must have a potable water capacity of not less than 20 gallons and a designated hose. The shop must have available hot water of not less than five gallons or hot water on demand. The shop must have a wastewater tank or gray water tank capacity at least 15 percent larger than the water supply holding tank. A mobile barber shop is precluded from operating when the potable water supply is insufficient to comply with infection control requirements or when the wastewater, black water, or gray water tank is at 90 percent or greater capacity. Requires that a mobile shop have an operating restroom with hand sink with potable water, soap, single use towels, and a flush toilet with a holding tank or composting toilet. Wastewater from a mobile barber shop must be discharged to a sanitary sewage system or sanitary dumping station. A mobile shop must have a sink, in addition to the restroom sink, with hot and cold running water. Sinks must be permanently installed and connected to the potable water supply and wastewater tanks. Makes the registrant responsible for complying with laws relating to the mobile barber shop.

Subd. 4 [Electrical and power requirements] specifies requirements for power generators and liquid petroleum gas systems in a mobile barber shop. Requires that heating and cooling systems be factory installed and meet requirements for heating and cooling systems in mobile vehicles or mobile structures. Requires working alarms for carbon monoxide, smoke, and combustible gas. Requires electrical wiring to comply with the state electrical code. Electrical equipment plugged into outlets must be UL-listed and comply with fire codes.

Subd. 5 [Safety, inspection, and infection control requirements] precludes a barber from providing services in a mobile barber shop unless the shop is parked with the engine off, stable, and level. Specifies how a mobile shop must be stabilized. Requires services to be provided inside the vehicle. Requires that hazardous substances be stored upright in secured cabinets when the shop is moving. Requires a ventilation system sufficient to provide fresh air. Requires all moving parts to be in good working order. Authorizes employees of the Board of Barber Examiners to enter and inspect a mobile shop during hours of service and normal business hours.

Subd. 6 [Compliance with local government law] requires a mobile barber shop to comply with local laws. Requires a mobile barber shop owner to be informed of legal requirements
