1.31 Page 38, line 31, before the first "applicant" insert "social equity"


1.32 Page 39, lines 2 and 3, before "applicant" insert "social equity"

1.34 "Subd. 5. Local unit of government. The office shall only issue a temporary license to
1.35 a local unit of government if, after assigning temporary licenses to social equity applicants,
1.36 there are remaining temporary licenses. A temporary license held by a local unit of
1.37 government must not count towards the limited number of licenses issued by a local
1.38 government unit under section 342.13, paragraph (h)."
