(a) For purposes of this section, the following terms have 1.4 1.5 the meanings given them. (b) "Commissioner" means the commissioner of public safety. 1.6 1.7 (c) "Deputy registrar" means a public or private deputy registrar appointed by the commissioner of public safety under section 168.33. 1.8 1.9 (d) "Driver's license agent" means a public or private driver's license agent appointed by the commissioner of public safety under section 171.06. 1.10 (e) "Equivalent materials" means written materials such as forms, applications, 1.11 questionnaires, letters, or notices that are used to ask or order a person to provide information 1.12 or to give a person information on provisions relevant to a person's rights, duties, or privileges 1.13 under chapters 168, 168A, and 171 offered in a qualifying language. 1.14 (f) "Qualifying language" means a language not in English and must include Spanish, 1.15 Hmong, Somali, Karen, Russian, Vietnamese, and any other language used by significant 1.16 populations within Minnesota as determined in subdivision 2. 1.17(g) "Substantial number" means 20 percent of the total number of transactions or office 1.18 visits at a given deputy registrar or driver's license agent location. 1.19 Subd. 2. Offering of translated materials required. (a) The commissioner must produce 1.20 equivalent materials for distribution and use by a deputy registrar or driver's license agent 1.21 to a non-English speaking person seeking the service of a deputy registrar or driver's license 1.22 agent. The commissioner must translate materials in English into a qualifying language and 1.23 prioritize translation of material that is distributed most frequently to the public. 1.24 (b) The commissioner, in consultation with the commissioner of administration, must 1.25 determine whether a location of an appointed deputy registrar or driver's license agent serves 1.26 a substantial number of non-English speaking people and whether the non-English speaking 1.27 population has access to equivalent materials in a qualifying language. If the commissioner 1.28 determines a location serves a substantial number of non-English speaking people, the 1.29 commissioner must notify the location and provide the equivalent material in all qualifying 1.30 languages to the deputy registrar or driver's license agent free of charge. If the commissioner 1.31 determines a location serves a substantial number of non-English speaking people, but the 1.32 language spoken is not a qualifying language, the commissioner must produce equivalent 1.33
