

1.1 Senator ..... moves to amend S.F. No. 4067 as follows:

1.2 Page 2, after line 33, insert:

1.3 "Sec. 4. Minnesota Statutes 2022, section 168.0135, is amended by adding a subdivision  
1.4 to read:

1.5 Subd. 2a. **Limitations.** (a) A vendor must not have an ownership interest with a deputy  
1.6 registrar or a driver's license agent.

1.7 (b) A vendor is not eligible to be appointed by the commissioner as a deputy registrar  
1.8 or a driver's license agent.

1.9 (c) An entity that owns, leases, or otherwise provides a location where a self-service  
1.10 kiosk is placed is not eligible to be appointed by the commissioner as a deputy registrar or  
1.11 a driver's license agent. This paragraph does not apply to a deputy registrar or a driver's  
1.12 license agent appointed prior to placement of a self-service kiosk within the office of the  
1.13 deputy registrar or driver's license agent.

1.14 **EFFECTIVE DATE.** This section is effective the day following final enactment."

1.15 Page 3, after line 19, insert:

1.16 "Sec. 6. Minnesota Statutes 2022, section 168.33, subdivision 8a, is amended to read:

1.17 Subd. 8a. **Electronic transmission.** (a) If the commissioner accepts electronic  
1.18 transmission of a motor vehicle transfer and registration by a new or used motor vehicle  
1.19 dealer, a deputy registrar who is equipped with electronic transmission technology and  
1.20 trained in its use ~~shall~~ must receive the filing fee provided for in subdivision 7 and review  
1.21 the transfer of each new or used motor vehicle to determine its genuineness and regularity  
1.22 before issuance of a certificate of title, and ~~shall~~ must receive and retain the filing fee under  
1.23 subdivision 7, paragraph (a), clause (2).

1.24 (b) The commissioner must establish reasonable performance, security, technical, and  
1.25 financial standards to approve companies that provide computer software and services to  
1.26 motor vehicle dealers to electronically transmit vehicle title transfer and registration  
1.27 information. An approved company must be offered access to department facilities, staff,  
1.28 and technology on a fair and reasonable basis. An approved company must not have an  
1.29 ownership interest with a deputy registrar or a driver's license agent. An approved company  
1.30 is not eligible to be appointed by the commissioner as a deputy registrar or a driver's license  
1.31 agent.

2.1 **EFFECTIVE DATE.** This section is effective the day following final enactment.

2.2 Sec. 7. Minnesota Statutes 2022, section 168A.085, is amended by adding a subdivision  
2.3 to read:

2.4 Subd. 4. **Foreign passport.** A valid and unexpired passport issued to the applicant by  
2.5 a recognized foreign government is a primary document for purposes of Minnesota Rules,  
2.6 part 7410.0400, and successor rules, when the applicant is an individual who is applying  
2.7 as the owner for a vehicle title or registration."

2.8 Page 20, after line 6, insert:

2.9 "Sec. 16. **FULL-SERVICE PROVIDER.**

2.10 (a) For purposes of this section, the following terms have the meanings given:

2.11 (1) "commissioner" means the commissioner of public safety; and

2.12 (2) "full-service provider" has the meaning given in Minnesota Statutes, section 168.002,  
2.13 subdivision 12a.

2.14 (b) A driver's license agent under Minnesota Statutes, section 171.061, who was appointed  
2.15 before January 1, 2024, and is recognized by the commissioner as a limited licensing agent  
2.16 under Minnesota Rules, part 7404.0340, may apply to the commissioner to become a  
2.17 full-service provider at the agent's current office location. A driver's license agent must  
2.18 submit an application on or before June 1, 2025. By June 30, 2025, an applicant under this  
2.19 section must satisfactorily complete any additional staff training required by the  
2.20 commissioner to offer expanded services as a full-service provider.

2.21 (c) The commissioner may appoint an applicant who meets the requirements under this  
2.22 section as a full-service provider.

2.23 (d) Minnesota Rules, chapter 7404, applies to an appointment under this section, except  
2.24 that this section applies notwithstanding Minnesota Rules, parts 7404.0300, subparts 4, 5,  
2.25 and 6; 7404.0305, subpart 1, item B; 7404.0345, item D; 7404.0350; 7404.0360, subpart  
2.26 2; and 7404.0400, subpart 4, item B."
