1.4 Page 1, delete section 2 and insert:

1.7 Subd. 8. **Officer to report accident to commissioner.** ~~A peace officer who, in the~~  
1.8 ~~regular course of duty, investigates an accident that must be reported under this section~~  
1.9 ~~shall, within ten days after the date of the accident, forward an electronic or written report~~  
1.10 ~~of the accident as prescribed by the commissioner of public safety. Within two business~~  
1.11 ~~days after identification of a fatality that resulted from an accident, the reporting agency~~  
1.12 ~~must notify the commissioner of the basic circumstances of the accident using an electronic~~  
1.13 ~~format as prescribed by the commissioner~~ (a) A peace officer who investigates in the regular  
1.14 course of duty an accident that is required to be reported under this section must submit an  
1.15 electronic or written report of the accident to the commissioner of public safety within ten  
1.16 days after the date of the accident. Within two business days after identification of a fatality  
1.17 that resulted from an accident, the reporting agency must notify the commissioner of the  
1.18 basic circumstances of the accident. A report or notification under this subdivision must be  
1.19 in the format as prescribed in subdivision 9.

1.20 (b) Accidents on streets, highways, roadways, sidewalks, shoulders, shared use paths,  
1.21 or any other portion of a road's public right-of-way must be reported under the requirements  
1.22 of this section if the accident results in:

1.23 (1) a fatality;

1.24 (2) bodily injury to a person who, because of the injury, immediately receives medical  
1.25 treatment away from or at the scene of the accident;

1.26 (3) one or more of the motor vehicles incurs disabling damage, requiring a vehicle to  
1.27 be transported away from the scene of the accident by tow truck or other vehicle; or

1.28 (4) damage to fixtures, infrastructure, or any other property alongside or on a public  
1.29 highway.

1.30 (c) An accident involving a school bus, as defined in section 169.011, subdivision 71,  
1.31 must be reported under the requirements of section 169.4511.

2.1 (d) An accident involving a commercial motor vehicle, as defined in section 169.011,  
2.2 subdivision 16, must be reported under the requirements of section 169.783.

2.3 (e) For purposes of this section, accidents occurring on public lands or trail systems that  
2.4 results in the circumstances specified in paragraph (c) must be reported."

2.5 Page 3, line 8, delete "off-road" and insert "off-highway"

2.6 Page 3, line 9, delete everything before the period and insert "section 84.771, and  
2.7 snowmobiles, as defined in section 84.81"
