Bill Description

This bill directs DPS to establish a new grant program to provide drivers with vouchers up to \$250 to use at participating auto repair shops to repair or replace broken or malfunctioning lighting equipment required under sections 169.49 to 169.51.

Sec. 2 provides an annual appropriation from the HUTD fund for \$1,200,000.

Assumptions

As directed in the bill, DPS would make a grant to the Lights On! organization to administer and manage the Lights On Grant Program.

Lights On! is an organization that already administers a microgram for this purpose. Through the grant, DPS would partner through a grant contract with Lights On! to utilize their existing processes to establish and manage the program.

DPS assumes it would utilize up to 5% of the appropriation for staff costs to administer the program as is allowed under Minnesota Statute 16B.98 subd. 14. (5% x 1,200,000 = up to \$60,000). Staff would administer and monitor the appropriation. Staff would also administer the grant with Lights On! including managing the grant contract, reviewing reimbursement requests, monitoring, and reporting.

DPS estimates a similar position to a state program administrator principal classification at an average rate of \$39.49/hour + 30% fringe rate = \$51.33/hour. DPS estimates 150 staff hours per year, or 0.07 FTE (150 hrs / 2088 = 0.07 FTE).

Expenditure and/or Revenue Formula

\$1,200,000 FY25 and beyond from the HUTD

150 hours / year x \$51.33/ hour (salary + fringe) = \$7,699.50 / fiscal year. (rounded to \$8,000)

150 hrs / 2088 = 0.07 FTE

Grant to Lights On! = \$1,192,000
