## "Sec. 2. Minnesota Statutes 2023 Supplement, section 62J.84, subdivision 10, is amended to read:

Subd. 10. Notice of prescription drugs of substantial public interest. (a) No later than 1.10 January 31, 2024, and quarterly thereafter, the commissioner shall produce and post on the 1.11 department's website a list of prescription drugs that the commissioner determines to represent 1.12 1.13 a substantial public interest and for which the commissioner intends to request data under subdivisions 11 to 14, subject to paragraph (c). The commissioner shall base its inclusion 1.14 of prescription drugs on any information the commissioner determines is relevant to providing 1.15 greater consumer awareness of the factors contributing to the cost of prescription drugs in 1.16 the state, and the commissioner shall consider drug product families that include prescription 1.17 1.18 drugs: (1) that triggered reporting under subdivision 3 or 4 during the previous calendar quarter; 1.19

(2) for which average claims paid amounts exceeded 125 percent of the price as of the
claim incurred date during the most recent calendar quarter for which claims paid amounts
are available; or

1.23 (3) that are identified by members of the public during a public comment process.

(b) Not sooner than 30 days after publicly posting the list of prescription drugs under
paragraph (a), the department shall notify, via email, reporting entities registered with the
department of the requirement to report under subdivisions 11 to 14.

- 1.27 (c) The commissioner must not designate more than 500 prescription drugs as having a1.28 substantial public interest in any one notice.
- 1.29(d) Notwithstanding subdivision 16 of this section, the commissioner is exempt from1.30chapter 14, including section 14.386, until December 31, 2024, in implementing this
- 1.31 subdivision.
- 1.32 **EFFECTIVE DATE.** This section is effective the day following final enactment."
