## **RE: Housing Support rate reduction**

Dear Chair Wiklund and Committee Members,

In July 2020, a state law was implemented requiring a 50% reduction of state funded Housing Support services for individuals determined eligible for Medicaid Housing Stabilization Services (HSS). Last year, during the 2023 Legislative Session, this rate reduction was repealed in state law, effective August 2023. However, Housing Support rate reductions continue to take place.

Stakeholders across the state have reported significant negative impact from the Housing Support rate reduction, including not being able to deliver critical services to people moving out of homelessness. Housing Support supplemental services are much broader in scope than HSS, and the rate reduction does not allow coverage of required Housing Support services.

On behalf of stakeholders across Minnesota, we are requesting permanent removal of the Housing Support rate reduction.

Left unaddressed, the consequences of the rate reduction remaining in place will lead to fewer housing options for Minnesotans experiencing or at-risk of homelessness, providers reducing or eliminating services altogether, and the state failing to leverage Medicaid funds to advance essential housing services.
