







# Why DCT Executive Board



- DCT has consistency of health care leadership
- Preserves clinical judgement of patient care
- Provides transparency to the operation of DCT programs and services
- Preserves and builds upon current progress

## **Greater Transparency**

- Board offers greater transparency and public accountability than exists under a more traditional commissioner-led model
- Board meetings are open to the public
- Issues are openly discussed
- Ample opportunities for public to provide input and ask questions
- Records of actions taken are available for public review

- Community-based support


## Stakeholder Feedback and Proposed Changes

### Proposed statute for new DCT chapter (246C)

- DCT needs to be included in statutes pertaining to state agency operations
- Executive Board membership, governance, powers and duties
- Date of transfer of authority and responsibility
- Technical changes

## Proposed Executive Board Makeup

## Seven voting members include

- **1** Psychiatrist or other physician experienced in behavioral health
- **1** Commissioner of human services
- 2 Members with experience on a hospital or nonprofit board
- **3** Members with background in health care administration, behavioral health, health care professions, traditional healing, or organized labor

## **Two non-voting members to include**

One appointed by the Association of Minnesota Counties, one by DCT labor unions

Voting members **may not** be current DCT or county employees, members of the Legislature, or staff or members of labor unions representing DCT. One voting member represents Greater Minnesota. One member must be from greater MN.
