
ABOUT US

THE DETAILS

ACCESS TO CAPITAL - FORTIS CAPITAL PARTICIPATION LOANS

Fortis Capital provides access to capital for Black, Indigenous, and Persons of Color businesses and entrepreneurs, as well as businesses in economically challenged communities. How does it work?

- 1. Fortis works with partner lenders who approve the potential credit for participation loans based on their standard analysis (capacity to pay, credit history, conditions, etc.)
- 2. Fortis then completes its own review of the credit request, with a goal of working with borrowers that <u>would not otherwise qualify</u> based on its higher participation percentage and risk mitigation factors used by traditional lenders.
- 3. Fortis is also able to reach borrowers that would not qualify for enough financing to satisfy their business needs.

Fortis Capital serves businesses who need higher loan participation based on collateral or credit deficiencies – purchasing **up to 75% participations in partner-approved loans**.

THE NEEDS

Fortis Capital is initially seeking growth in two phases:

- 1. \$2,000,000 in grants, forgivable loans and private philanthropy for infrastructure (staffing, overhead, etc.) to attract and retain qualified portfolio management and loan servicing staff.
- 2. \$10M \$20M in grants and low-interest loans (Program Related Investments, EQ2 loans, etc.) to increase capacity including expanding to serve the greater Twin Cities area, with future expansion statewide.
