- 3.22 (1) bill tenants according to the provisions of section 216B.023, subdivision 1, paragraphs
3.23 (a) to (c);
- 3.24 (2) charge tenants according to the provisions of section 216B.023, subdivision 2,
3.25 paragraphs (a) to (c); and
- 3.26 (3) comply with sections 216B.022, subdivision 4, and 216B.023, subdivisions 5, 6, 7,
3.27 and 8.
- 3.28 (c) A landlord may not charge to or collect from tenants any administrative, capital, or
3.29 any other expenses associated with the installation, maintenance, repair, replacement, or

4.1 reading of submeters, unless the expense is due to the tenant's willful, malicious, or negligent
4.2 conduct."

4.6 "(b) A landlord who apportions natural gas or water and sewer, or both, must include
4.7 in the lease a provision that, upon a tenant's request, the landlord must provide a copy of
4.8 the actual natural gas water or sewer utility bill for the building along with each apportioned
4.9 water or sewer utility bill. Upon a tenant's request, a landlord must also provide past copies
4.10 of water or sewer utility bills for any period of the tenancy for which the tenant received
4.11 an apportioned utility bill."

4.13 "Subd. 6. **Apportionment of natural gas.** A landlord may apportion natural gas used
4.14 only in the tenant's unit and may apportion fixed meter or services charges and taxes only
4.15 according to the formula set forth in clauses (1) to (4) and as agreed to by the landlord and
4.16 tenant in the lease or a written agreement:

4.17 (1) a tenant's apportioned natural gas usage must be based solely on the square footage
4.18 in the tenant's unit. A landlord may not charge any tenant for natural gas consumed in
4.19 common areas or in spaces used exclusively or primarily by the landlord;

4.20 (2) if there is a fixed meter or service charge on the bill the landlord receives from the
4.21 utility provider, the landlord may apportion to the tenant only the tenant's pro rata share of
4.22 that charge, calculated by dividing the charge as shown on the bill issued to the landlord by
4.23 the utility provider equally among the number of units in the building;

4.24 (3) the landlord may charge a tenant only for the tenant's pro rata share of the taxes,
4.25 surcharges, and flat fees by dividing the sum of those charges as shown on the bill issued
4.26 to the landlord by the provider equally among the number of units in the building; and

4.27 (4) the landlord must deduct from a tenant's total bill the tenant's pro rata share of any
4.28 bill credits or adjustments received by the landlord on the bill from the utility provider by
4.29 dividing the credit or adjustment equally among the number of units in the building.

4.30 Subd. 7. **Apportionment of water and sewer.** A landlord may apportion water used
4.31 only in the tenant's unit and may apportion fixed meter or services charges, fixed sewer

5.1 charges, and taxes only according to the formula set forth in clauses (1) to (4) and as agreed
5.2 to by the landlord and tenant in the lease or a written agreement:

5.3 (1) a tenant's apportioned water usage must be based solely on a combination of square
5.4 footage in the tenant's unit and the unit's occupancy. A landlord may not charge any tenant
5.5 for water usage in common areas, for maintenance of the property, for amenities including
5.6 but not limited to laundry facilities and pools, or in spaces used exclusively or primarily by
5.7 the landlord;

5.8 (2) if there is a fixed meter or service charge on the bill the landlord receives from the
5.9 utility provider, the landlord may apportion to the tenant only the tenant's pro rata share of
5.10 that charge, calculated by dividing the charge as shown on the bill issued to the landlord by
5.11 the utility provider equally among the number of units in the building;

5.12 (3) the landlord may charge a tenant only for the tenant's pro rata share of the taxes,
5.13 surcharges, and flat fees by dividing the sum of those charges as shown on the bill issued
5.14 to the landlord by the provider equally among the number of units in the building; and

5.15 (4) the landlord must deduct from a tenant's total bill the tenant's pro rata share of any
5.16 bill credits or adjustments received by the landlord on the bill from the utility provider by
5.17 dividing the credit or adjustment equally among the number of units in the building.

5.18 Subd. 8. **Administrative billing charge.** A landlord who bills separately from rent for
5.19 any utility service may charge a tenant a single administrative billing fee per billing period
5.20 for all the utilities that are separately billed that do not exceed \$8. No other fees may be
5.21 charged to or collected from tenants for utility service, including but not limited to any
5.22 administrative, capital, or any other expenses associated with the installation, maintenance,
5.23 repair, replacement, or reading of submeters, unless the expense involving a submeter is
5.24 due to the tenant's willful, malicious, or negligent conduct."

5.26 Renumber the subdivisions in sequence

5.27 Page 11, delete lines 5 to 8 and insert:

5.28 "(2) an eviction action may not be filed and any eviction already filed must be stayed
5.29 for:

5.30 (i) the failure to pay gas or electric utility service charges during the cold weather period;

5.31 (ii) the failure to pay electric utility charges during a heat emergency; and

6.1 (iii) if the tenant notifies the landlord or the court that the tenant or a member of the
6.2 tenant's household is experiencing a medical emergency or where medical equipment
6.3 requiring electricity necessary to sustain life is in use and certification of the emergency is
6.4 provided to the landlord or the court by a licensed medical health care professional within
6.5 three days of notification to the landlord or the court; and"

6.7 "Subd. 11. **Violations.** A violation of subdivisions 2 to 9 is a violation of sections
6.8 504B.161 and 504B.221."
