179.06 COLLECTIVE BARGAINING AGREEMENTS.

Subdivision 1. Notices. (a) When any employee, employees, or representative of 2.14 employees, or labor organization shall desire to negotiate a collective bargaining agreement, 2.15 or make any change in any existing agreement, or shall desire any changes in the rates of 2.16 pay, rules or working conditions in any place of employment, it shall give written notice to 2.17 the employer of its demand, which notice shall follow the employer if the place of 2.18 2.19 employment is changed, and it shall thereupon be the duty of the employer and the representative of employee or labor organization to endeavor in good faith to reach an 2.20 agreement respecting such demand. An employer shall give a like notice to employees, 2.21 representative, or labor organizations of any intended change in any existing agreement. If 2.22 no agreement is reached at the expiration of ten days after service of such notice, any 2.23 employees, representative, labor organization, or employer may at any time thereafter 2.24 petition the commissioner of mediation services to take jurisdiction of the dispute and it 2.25 shall be unlawful for any labor organization or representative to institute or aid in the conduct 2.26 of a strike or for an employer to institute a lockout, unless such petition has been served by 2.27 the party taking such action upon the commissioner and the other parties to the labor dispute 2.28 at least ten days before the strike or lockout becomes effective. Unless the strike or lockout 2.29 is commenced within 90 days from the date of service of the petition upon the commissioner, 2.30 it shall be unlawful for any of the parties to institute or aid in the conduct of a strike or 2.31 lockout without serving a new petition in the manner prescribed for the service of the original 2.32

3.1 petition, provided that the 90-day period may be extended by written agreement of the3.2 parties filed with the commissioner.

(b) A petition by the employer shall be signed by the employer or a duly authorized 3.3 officer or agent; and a petition by the employees shall be signed by their representative or 3.4 its officers, or by the committee selected to negotiate with the employer. In either case the 3.5 petition shall be served by delivering it to the commissioner in person or by sending it by 3.6 certified mail addressed to the commissioner at the commissioner's office. The petition shall 3.7 state briefly the nature of the dispute and the demands of the party who serves it. Upon 3.8 receipt of a petition, the commissioner shall fix a time and place for a conference with the 3.9 parties to the labor dispute upon the issues involved in the dispute, and shall then take 3.10 whatever steps the commissioner deems most expedient to bring about a settlement of the 3.11 dispute, including assisting in negotiating and drafting a settlement agreement. It shall be 3.12 the duty of all parties to a labor dispute to respond to the summons of the commissioner for 3.13 joint or several conferences with the commissioner and to continue in such conference until 3.14 excused by the commissioner, not beyond the ten-day period heretofore prescribed except 3.15 by mutual consent of the parties. 3.16

3.17 Subd. 2. **Commissioner, powers and duties.** The commissioner may at the request of 3.18 either party to a labor dispute render assistance in settling the dispute without the necessity 3.19 of filing the formal petition referred to in <u>under</u> subdivision 1. If the commissioner takes 3.20 jurisdiction of the dispute as a result of such a request, the commissioner shall <u>must</u> then 3.21 proceed as provided in according to subdivision 1.

(a) "Supervisory employee" means a person who has 9.2 the authority to undertake a majority of the following supervisory functions in the interests 9.3 of the employer: hiring, transfer, suspension, promotion, discharge, assignment, reward, or 9.4 discipline of other employees, direction of the work of other employees, or adjustment of 9.5 other employees' grievances on behalf of the employer. Subd. 2. Right to organize. (a) Public employees have the right to form and join labor 10.2 or employee organizations, and have the right not to form and join such organizations. 10.3 Public employees in an appropriate unit have the right by secret ballot to designate an 10.4 exclusive representative to negotiate grievance procedures and the terms and conditions of 10.5 employment with their employer. Confidential employees of the state, confidential court 10.6 employees, and confidential University of Minnesota employees are excluded from 10.7 10.8 bargaining. Supervisory and managerial court employees are excluded from bargaining. Supervisory, managerial, and confidential employees of Hennepin Healthcare System, Inc., 10.9 are excluded from bargaining. Other confidential employees, supervisory employees, 10.10 principals, and assistant principals may form their own organizations. An employer shall 10.11 extend exclusive recognition to a representative of or an organization of supervisory or 10.12 confidential employees, or principals and assistant principals, for the purpose of negotiating 10.13 terms or conditions of employment, in accordance with sections 179A.01 to 179A.25, 10.14 applicable to essential employees. 10.15

(b) Supervisory or confidential employee organizations shall not participate in any 10.16 capacity in any negotiations which involve units of employees other than supervisory or 10.17 confidential employees. (a) An exclusive representative may require employees who 10.31 are not members of the exclusive representative to contribute a fair share fee for services 10.32 rendered by the exclusive representative.
