2.6 when employed by the original employer, and are entitled to use all earned sick and safe
2.7 time previously accrued but not used.

2.8 (b) ~~If, at the time of transfer of the business,~~ employees are terminated by the original
2.9 employer and hired within 30 days by the successor employer following the ~~transfer~~ employer
2.10 succession, those employees are entitled to all earned sick and safe time accrued but not

2.12 safe time previously accrued but not used.
