2.7 \$10,000,000 in fiscal year 2026 is appropriated from the general fund to the commissioner
2.8 of agriculture for a grant to the First District Association, a dairy cooperative located in the
2.9 city of Litchfield to design, engineer, construct, equip, and furnish a new wastewater
2.10 industrial pretreatment facility in the city of Litchfield. This appropriation is in addition to
2.11 the appropriation in Laws 2023, chapter 71, article 1, section 15, subdivision 7, and is for
2.12 the same purpose.

2.13 **EFFECTIVE DATE.** This section is effective the day following final enactment.
