(b) The solar pollinator program plate application must indicate that the annual 1.20

contribution specified under paragraph (a), clause (4), is a minimum contribution to receive

the plate and that the applicant may make an additional contribution to the account.

2.4	Subd. 3. Plates transfer. On application to the commissioner and payment of a transfer
2.5	fee of \$5, special plates issued under this section may be transferred to another motor vehicle
2.6	if the subsequent vehicle is:
2.7	(1) qualified under subdivision 1, paragraph (a), clause (1), to bear the special plate; and
2.8	(2) registered to the same individual to whom the special plates were originally issued.

2.24	(2) rotational or conservation grazing;
2.25	(3) providing perennial vegetation for pollinator habitat and soil and water benefits under
2.26	subdivision 2;
2.27	(4) production of agricultural commodities for sale in the retail or wholesale market; or
2.28	(5) any of the above practices together with other activities under this section to produce
2.29	soil and water benefits.

- (b) An owner making an agrivoltaics claim under this section must also provide the site's
 agrivoltaics management plan and management practices report for agency feedback in the
 manner described in subdivision 2.
