

## SC3253-6 – Modifications

**SC3253-6** amends earlier appropriations and makes related changes. Appropriations amended in these sections were made from the general fund and enacted in 2023, unless otherwise specified.

**Section 1. Chisago County; U.S. Highway 8 Reconstruction.** Sets the availability of an appropriation to December 31, 2029, for a grant to Chisago County for improvements to Highway 8. This is an appropriation from bond proceeds enacted in 2020. SF 2354 (Jasinski).

**Section 2. White Bear Lake Communities; Lake Links Trail.** Allows the city of Dellwood to break its project for the Lake Links Trail into components and to have separate grant agreements for each segment. This amends an appropriation of bond proceeds enacted in 2020 as amended in 2023. SF 3435 (Housley).

**Section 3. Metropolitan Council.** Extends the availability of an appropriation for the North Commons Improvement Project under a grant to the Minneapolis Park and Recreation Board, until December 31, 2026.

**Section 4. St. Anthony Falls.** Extends an appropriation for a geophysical study and hazard assessment of the St. Anthony Falls area and the St. Anthony Falls cutoff wall by the University of Minnesota, to June 30, 2026. Extends the deadline for completion of the study. This is currently in the House's 2025 State Government Omnibus bill (SF3045-2UE).

**Section 5. Sustainable Building Guidelines; Recommendations and Report.** Allows an unspent amount of an appropriation for developing recommendations to update the sustainable building guidelines to be used to implement the guidelines.

**Section 6. Amateur Sports Commission.** Amends an appropriation for a skate park grant program to provide grants to named recipients, instead of grants through a competitive grant program, and to change the fiscal agent for the grants from the Amateur Sports Commission

to the department of employment and economic development. Related section 27, paragraph (b), repeals the grant program.

**Section 7. Marshall; MERIT Training Center.** Eliminates firearms support buildings and a live burn buildout structure from the allowed uses of a grant to the city of Marshall for a MERIT training center. SF 788 (Dahms).

**Section 8. Dellwood; Lake Links Trail.** Extends an appropriation to December 31, 2028, and authorizes the money to be granted through more than one grant to the city of Dellwood for a portion of the Lake Links Trail. SF 3435 (Housley).

**Section 9. Maple Grove; Community Center.** Adds construction as an allowed use of an appropriation for grant to Maple Grove for a community center. SF 64 (Limmer).

**Section 10. St. Cloud; CentraCare.** Adds allowed construction activities for an appropriation for medical school facilities in St. Cloud through a grant to CentraCare. SF 1929 (Putnam).

**Section 11. Isuroon.** Authorizes amounts remaining from an appropriation after renovating one property to be used to acquire property and to renovate and construct a specialty care center in the metropolitan area, through a grant to Isuroon. SF 3452 (Hoffman).

**Sec. 12. Open Arms.** Adds HVAC improvements at a nutrition counseling center building in Minneapolis to the allowed uses of an appropriation for a grant to Open Arms. SF 3451 (Pappas).

**Section 13. The Link.** Eliminates “construct, furnish, and equip” from the funded actions for a multiuse facility in North Minneapolis through a grant to The Link.

**Section 14. Total appropriation.** A conforming change related to the amendment to the First District appropriation in section 16. SF 1299 (Lang).

**Section 15. Braham; Clean Water Infrastructure.** Eliminates water well replacement from the project description for a grant to the city of Braham for clean water infrastructure.

**Section 16. First District Association; Wastewater Industrial Pretreatment Facility.** Changes the fiscal agent from the Public Facilities Authority to the commissioner of agriculture for a grant to the First District Association dairy cooperative for a wastewater industrial pretreatment facility in Litchfield. SF 1299 (Lang).

**Section 17. Western Lake Superior Sanitary District; Clarifiers.** Extends an appropriation for secondary clarifiers in the wastewater treatment system, through a grant to the Western Lake Superior Sanitary District to December 31, 2029. SF 2914 (McEwen).

**Section 18. Heartland State Trail.** Allows an unspent portion of an appropriation for the Heartland Trail to be used for environmental review, engineering, and design of additional segments of the trail. This appropriation is from bond proceeds enacted in 2023. SF 3344 (Kupec).

**Section 19. Savage; Road and Bridge Improvements.** Extends an appropriation for a grant to the city of Savage for road and bridge improvements to December 31, 2029. This appropriation is from bond proceeds enacted 2023. SF 3450 (Port).

**Section 20. Minnesota State Colleges and Universities.** Adds replacement of a portion of a roof to the allowed uses of an appropriation for the Heintz Center at the Rochester Community and Technical College. SF3466 (Nelson).

**Sections 21 (Appropriation; Capitol Area Improvements), 22 (Cancellation), and 23, paragraph (a) (Repealer)** work together to make changes to an appropriation from 2023 for improvements in the Capitol Area. In 2023, \$5,000,000 was transferred from the general fund to a special revenue account and appropriated to the commissioner of administration for grants to improve the livability, economic health, and safety of communities within the Capitol Area. The money was not authorized to be expended until a task force provided recommendations. These sections cancel that appropriation, transfer the \$5,000,000 back to the general fund, and appropriate the \$5,000,000 from the general fund for grants for the uses recommended by the task force. These provisions are in the senate's 2025 omnibus State and Local Government and Elections bill, SF 3045 (Xiong).
