Section 1. **SAFE ROUTES TO SCHOOL.**

Subdivision 1. **Appropriation.** \$10,000,000 is appropriated from the bond proceeds

fund to the commissioner of transportation for grants under Minnesota Statutes, section

Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond

proceeds fund, the commissioner of management and budget shall sell and issue bonds of
