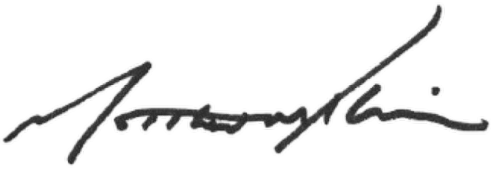
S.F. 1758: Senator Dahms: Board of directors of the Minnesota Insurance Guarantee Association permission to request financial information from insureds.
