

S.F. No. 2511 – Omnibus Liquor Bill (as amended by the A-7 Delete Everything Amendment)

S.F. 2511 establishes the Minnesota Senate Commerce and Consumer Protection Committee Liquor Policy.

Section 1 (S.F. 2202; amends section 340A.404, subdivision 2b) authorizes the city of St. Paul to issue on-sale intoxicating liquor licenses to the Science Museum of Minnesota and the Union Depot.

Section 2 (S.F. 2221; amends 340A.404, subdivision 4a) authorizes the commissioner of public safety to issue on-sale intoxicating liquor licenses to entities hold a concessions contract with the Board of Regents of the University of Minnesota, subject to certain limitations and requirements.

Section 3 (S.F. 2221; amends section 340A.412, subdivision 4) removes the prohibition against issuing a license to sell intoxicating liquor on the campus of the College of Agriculture of the University of Minnesota.

Section 4 (amends section 340A.417) authorizes a winery located outside of Minnesota or a winery located within Minnesota to ship not more than four cases of wine to any resident of Minnesota age 21 or over.

Section 5 [340A.911 Social District License] establishes a statewide social district license which authorizes cities to issue social district licenses to any holder of an on-sale license whose on-sale premises is contiguous with the premises of the social district, subject to certain requirements. Cities are required to report certain information to the chairs and ranking minority members of the legislative committees with jurisdiction over liquor regulation.

Section 6 (S.F. 1654; amends Laws 2017, First Special Session chapter 4, article 5, section 12) authorizes the city of Minneapolis to issue an on-sale intoxicating liquor license to additional locations.

Section 7 (S.F. 265) authorizes the city of Mankato to issue an on-sale wine and malt liquor intoxicating liquor license to Minnesota State University, Mankato.

Section 8 (S.F. 1168) authorizes the city of Rochester to issue an on-sale intoxicating liquor license to the Historic Chateau Theater.

Section 9 (S.F. 1588) authorizes the city of Bloomington to issue an on-sale malt liquor license and an on-sale wine license for the Bloomington Dwan Golf Course.

Section 10 (S.F. 1655) authorizes Lake of the Woods County to issue temporary licenses for the Baudette Arena Association.

Section 11 (S.F. 2059) authorizes the city of St. Louis Park to issue an on-sale intoxicating liquor license to the Shops at West End.

Section 12 (S.F. 2376) authorizes the city of Springfield to issue an on-sale intoxicating liquor license, an on-sale wine license, and strong beer license, or an on-sale including Sunday intoxicating liquor license for the Springfield Area Community Center.

Section 13 authorizes Douglas County to issue temporary licenses to food trucks for the onsale intoxicating liquor at private events. This section expires one year after the date of approval by the Douglas County Board of Commissioners.
