S.F. 0863 (Putnam): Prohibiting being fired for running for office

Senator Westlin moved the A2 Author's Amendment. By a voice vote, the motion prevailed.

Senator Mathews moved an Oral Amendment to the A2 Author's Amendment.

On 1.17, delete "subject" and reinstate "guilty of"

On 1.18, delete all of the new language

By a voice vote, the motion failed.

Senator Mathews called for division. By a hand count vote of 6/4, the motion for the Oral Amendment to the A2 Author's Amendment prevailed.

Senator Port moved that S.F. 0863, as amended, is recommended to pass and re-referred to the Rules and Administration. By a voice vote, the MOTION PREVAILED.

• S.F. 0828 (Boldon): Working group on local campaign finance reporting

Senator Boldon moved the A2 Author's Amendment. By a voice vote, the motion prevailed.

Senator Bahr moved an Oral Amendment to the A2 Amendment to SF 0529.

On 1.3, delete "small city" and insert "city of the fourth class" By a voice vote, the motion prevailed.

Senator Mathews moved an Oral Amendment to the A2 Amendment to SF 0529.

On 2.2-2.4, delete "one member" and insert "two members"

On 2.9, after "(b)" insert "In making appointments pursuant to clauses (4) to (6), the appointing authorities must appoint one member who resides outside the metropolitan area as defined in section 473.121, subdivision 2."

Senator Westlin requested a roll call vote for the adoption of Senator Mathews's Oral Amendment to the A2 Amendment. With a vote of 5/6, the motion failed.

Senator Carlson moved that S.F. 0828, as amended, be recommended to pass, and re-referred to the State & Local Government Committee. By a voice vote, the motion prevailed.

S.F. 0828, as amended, is recommended to pass, and re-referred to the State & Local Government Committee.

 S.F. 0569 (Marty): A resolution memorializing Congress to overturn the United States Supreme Court Citizens United v. FEC; requesting that Congress clarify that the rights are protected under the Constitution are the rights of natural persons and not the rights of artificial entities and that spending money to influence elections is not speech under the First Amendment; asking that Congress propose a constitutional amendment to provide such a clarification
