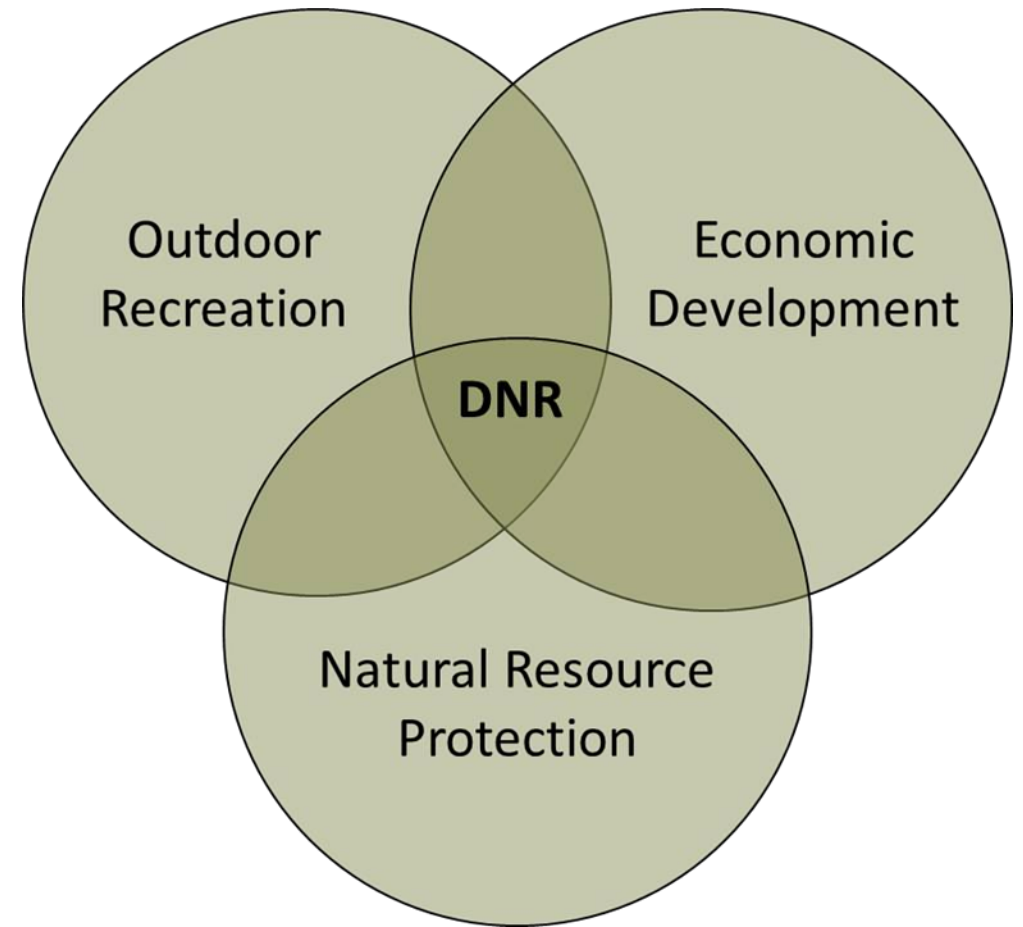

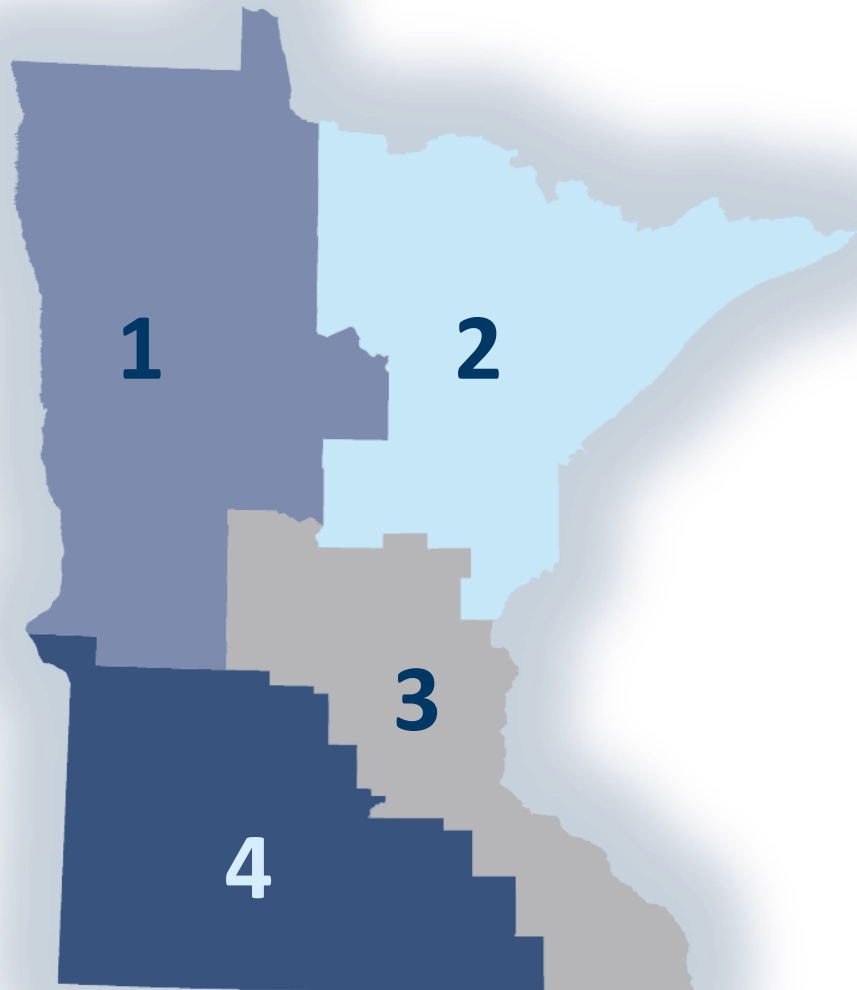

Region 3: Central – Grant Wilson, Director

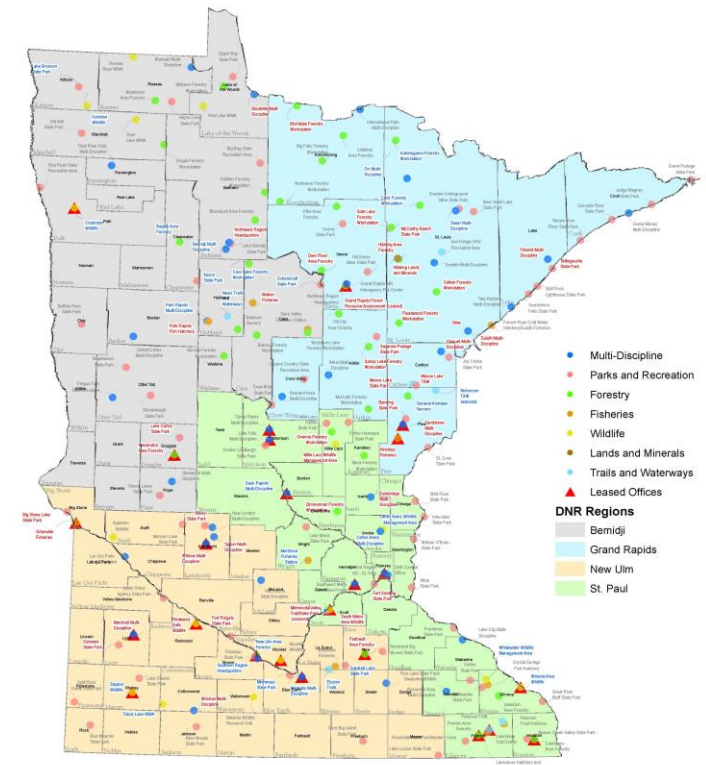

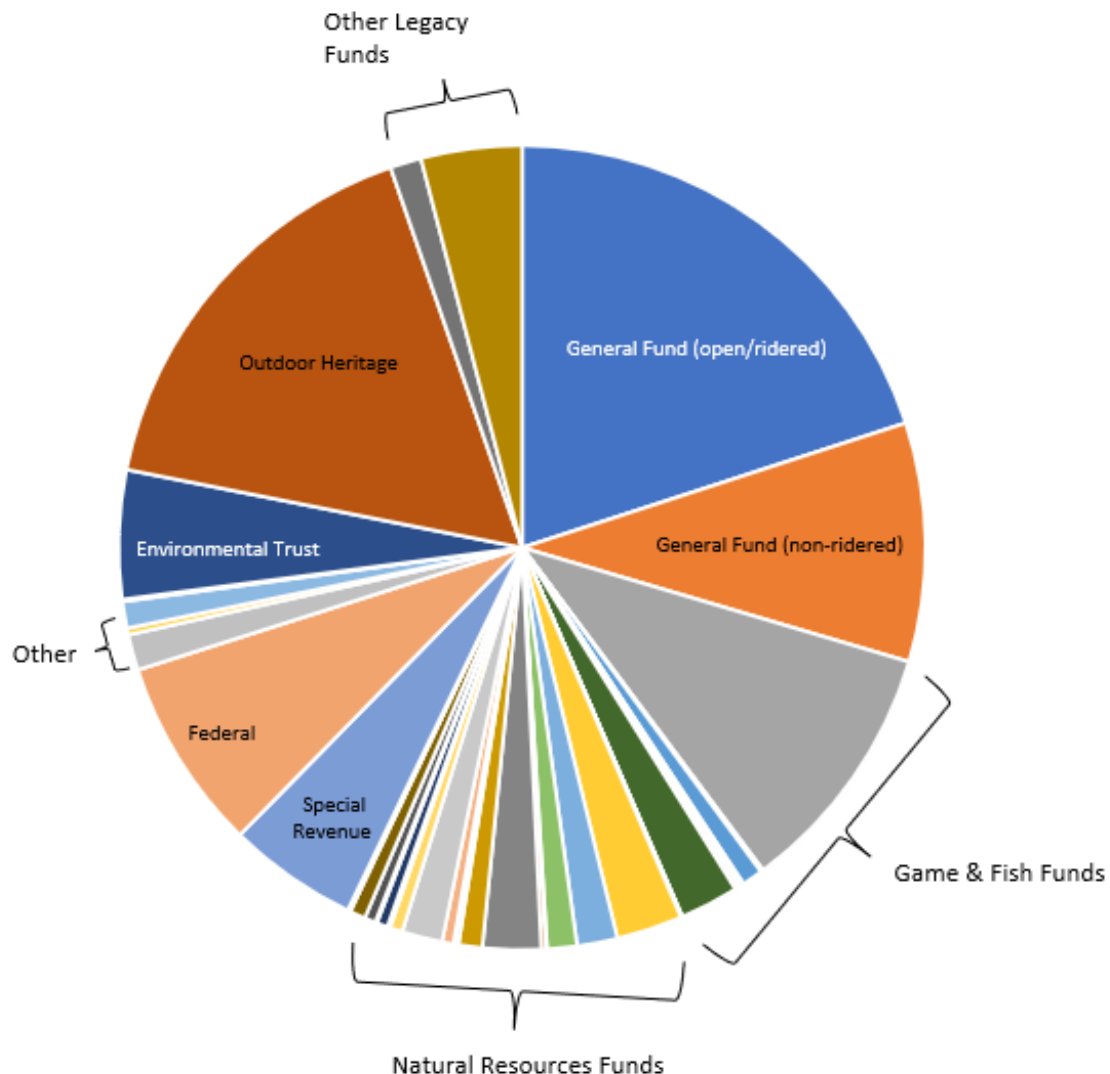

DNR By the Numbers

- 60 state forests
- 170 scientific and natural areas
- 64 state parks, 9 state recreation areas, and 9 state waysides
- 700 aquatic management areas
- 1,500 miles of multi-use state trails
- 22,300 miles of grants-in-aid trails (3,500 OHV, 870 ski, and 22,300 snow)
- 4,100 miles of hiking, biking, horse, and motorized trails within state park, state recreation area, and state forest lands
- 1,700 public water access sites and 390 fishing piers, platforms, and shore-fishing sites
- 1,069,000 angling and 827,000 hunting licenses sold
- 812,000 registered boats
- 203,000 registered snowmobiles and 375,000 registered all-terrain vehicles (ATVs)
- 11.3 million state park and recreation area visitors, with 1.14 million overnight visitors served
- Over 7,000 native animals and plants assessed for conservation status updates
- Over 60 wildlife game species managed
- 240 million walleye fry and 1.8 million walleye fingerlings stocked

FY24-25 Budget by Fund



- FY24-25 budget is roughly \$2 billion
- Spread across more than 50 funds
- Primary operating funds:
 - Natural Resources Funds (13%)
 - Game and Fish Funds (14%)
 - General Fund (30%)
- The DNR makes up less than 1% of the state's general fund spending
- One-time funding from legacy funds and the environmental trust are 27% of our budget
- 22% of our budget is passed through to non-state entities

Lands and Minerals Division



- Manages agency real estate transactions and real estate portfolio
- Regulates, and provides expertise on mineral exploration, mining, and mine land reclamation
- Manages mineral interests on all state trust and county lands
- Manage payments and mineral valuation claims for tax forfeit properties
- Developing a regulatory framework for gas extraction and production

- **Lands and Minerals by the Numbers:**
 - Manages real estate activities for 5.6 million acres of state-owned land, including 2.5 million acres of school trust lands
 - Administered 2,550 state land leases in CY23
 - Manages 12 million acres of state-owned mineral rights
 - 272 active mineral leases; 158 active leases for non-ferrous minerals

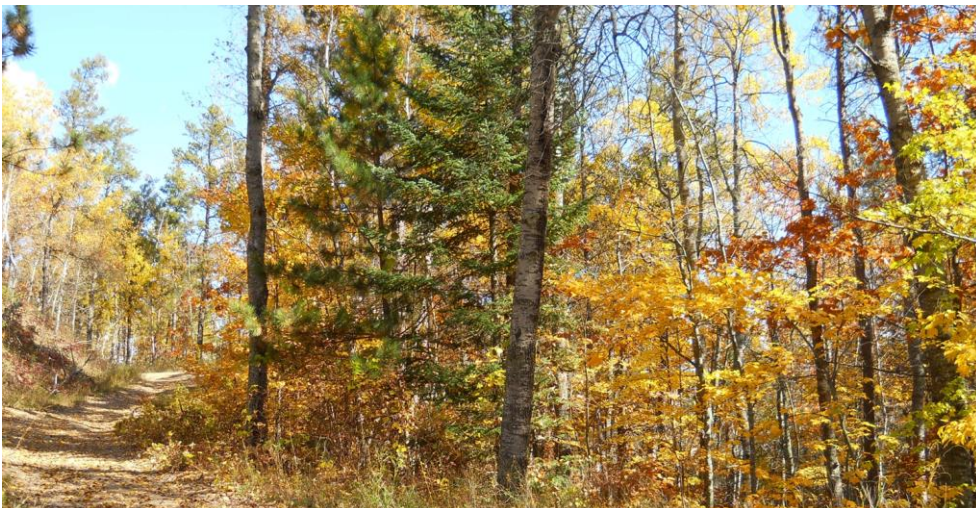
Ecological and Water Resources Division

- Ensures the long-term health of lands and waters that support and maintain water quality, biodiversity, and vital ecosystem services
- Provides critical information and regulatory oversight to state and local governments, businesses, and landowners to foster natural resources stewardship
- **Division Director:** Katie Smith
- **Assistant Directors:** Melissa Kuskie, Jason Moeckel
- **Ecological and Water Resources by the Numbers:**
 - 170 Scientific Natural Areas (SNA) covering 193,000 acres
 - 15,350 acres in prairie bank easements
 - Over 52,700 inspections for Aquatic Invasive Species (AIS) conducted in 2023
 - 874 new water appropriation permits issued in FY2024
 - 1,250 groundwater observation wells



Forestry Division

- Protects citizens, property, and natural resources from wildfire
- Provides a sustainable yield of forest resources for forest products, clean water, wildlife habitat, and recreation
- Manages School Trust surface resources (forest products, gravel)



- **Division Director:** Patty Thielen
- **Deputy Director:** Andrew Arends
- **Forestry by the Numbers:**
 - Respond to average of 960 fires annually
 - 60 State Forests
 - 5 million acres of DNR-administered forest land included in our forest certification certificate
 - Provides about 1/3 of the fiber used by mills across the state
 - 30,000 acres reforested annually
 - Annual average of 70,000 acres of private land included in forest management plans
 - Maintains about 2,400 miles of state forest roads

Parks and Trails Division

- Operates a system of state parks and state forest recreation areas that conserves natural, scenic, and cultural resources
- Maintains a statewide network of recreational trails
- Provides public access to lakes, rivers, and streams
- Provides environmental education, and grants for regional and community recreation opportunity



- **Division Director:** Ann Pierce
- **Deputy Director:** Phil Leversedge
- **Parks and Trails by the Numbers**
 - Operate 64 State Parks, 9 State Recreation Areas, 9 state waysides and more than 5,000 campsites
 - 1.14 million overnight visitors in 2023
 - 3,400 miles of hiking/biking/motorized trails and 22,300 miles of snowmobiles trails
 - Maintain 1,700 public water accesses, 390 fishing piers, 35 state water trails
 - Deliver approximately 8,600 outdoor education programs to 200,000 participants each year

Fish and Wildlife Division

- Manages fish and wildlife populations and provides related outdoor recreation opportunities
- Conserves, and enhances water and land habitats, regulates hunting, trapping and fishing



- **Division Director:** Kelly Straka
- **Deputy Director:** Pat Rivers
- **Fish and Wildlife by the Numbers:**
 - 1.1 million angling licenses sold
 - 548,000 licensed hunters and trappers
 - More than 1,500 WMAs covering 1.3 million acres
 - Managed 4,400 fishing lakes
 - Stocked 1,370 lakes and 126 streams with fish in 2023
 - Over 4,000 designated trout stream miles

Enforcement Division

- Enforces natural resource laws including those related to game and fish, wetlands, aquatic plants, and the operation of recreational vehicles
- Regulates natural resource commercial operations
- Provides conservation and safety education programs
- Provides disaster and emergency response



- **Division Director:** Colonel Rodmen Smith
- **Deputy Director:** Lt. Colonel Robert Gorecki
- **Enforcement by the Numbers:**
 - 154 Conservation Officers in the field
 - 51,000 students certified annually in ATV, snowmobile, boat, and firearms safety
 - 25,000 documented contacts in FY2024
 - Worked with over 100 non-profit shooting sports organizations to increase capacity for HS shooting sports and recreational shooting through infrastructure improvements and expansions

Operations Services Division

- Provides administrative leadership and support to the department
- Support staff through human resources
- Manage safety, emergency preparedness, and disaster response
- Maintain fleet, buildings, and infrastructure



- **Division Director:** Reena Solheid
- **Deputy Director:** Judy Schmidt
- **Operations Support by the Numbers:**
 - Manages over 2,900 DNR buildings across the state
 - Over 5,000 pieces of mobile equipment managed, which includes 3,280 fleet land operated items
 - Over 64 million views of DNR website in 2024
 - Approximately 95,000 public contacts made to DNR Information Center
