Minnesota Statutes 2024, section 97B.001, subdivision 4, is amended to read: 1.6 Subd. 4. Entering posted land prohibited; signs. (a) Except as provided in subdivision 1.7 6, a person may not: 1.8 (1) enter, for outdoor recreation purposes, any land that is posted under this subdivision 1.9 without first obtaining permission of the owner, occupant, or lessee; or 1.10 (2) knowingly enter, for outdoor recreation purposes, any land that is posted under this 1.11 subdivision without first obtaining permission of the owner, occupant, or lessee.
