RE: Appropriation and Local Match History to Area II Minnesota River Basin

Senate File 946 / House File 939

Prior to my testimony on April 1, 2025, I would like to provide background information regarding State appropriations to Area II Minnesota River Basin Projects (Area II).

Formed in 1978 by statute, Area II is a 9-county joint powers organization in southwestern Minnesota for the purpose of floodwater retention and retardation. The organization received \$250,000 per year from the State of Minnesota until the mid-1980's when a 25% reduction occurred due to economic conditions. The reduced level of \$189,000 was maintained until 2002, and since then, the appropriation has varied ever since. As the table below illustrates, the dedication of the member counties has not waivered by providing more than the required 25% match to the State funds.
