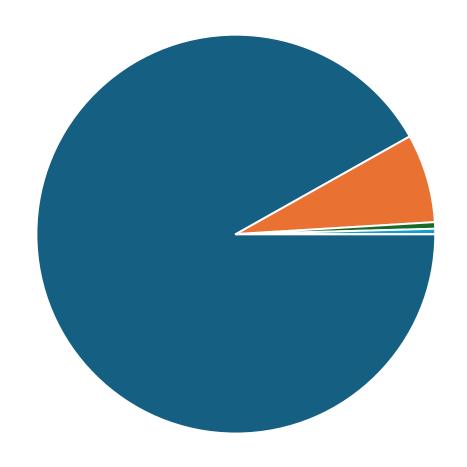

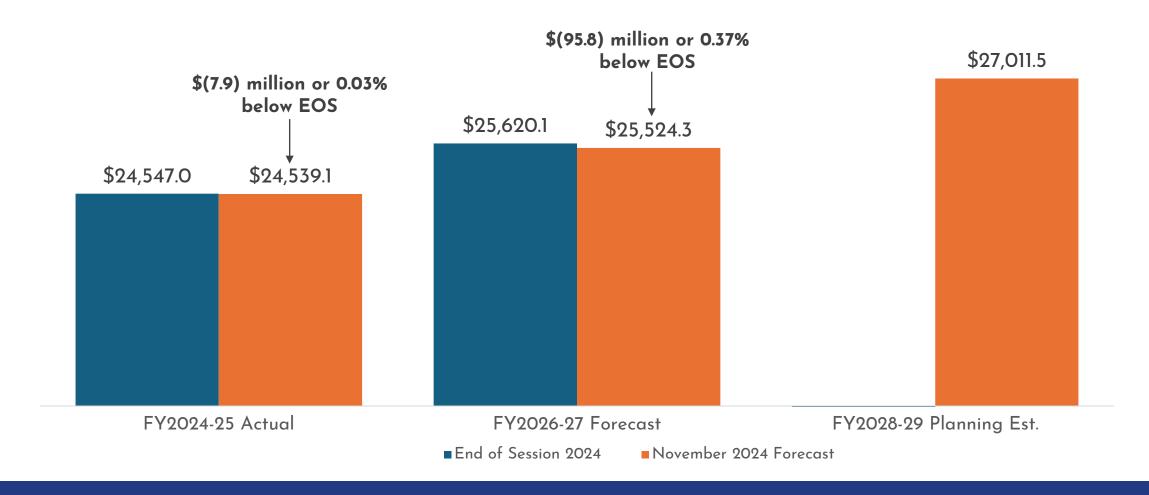

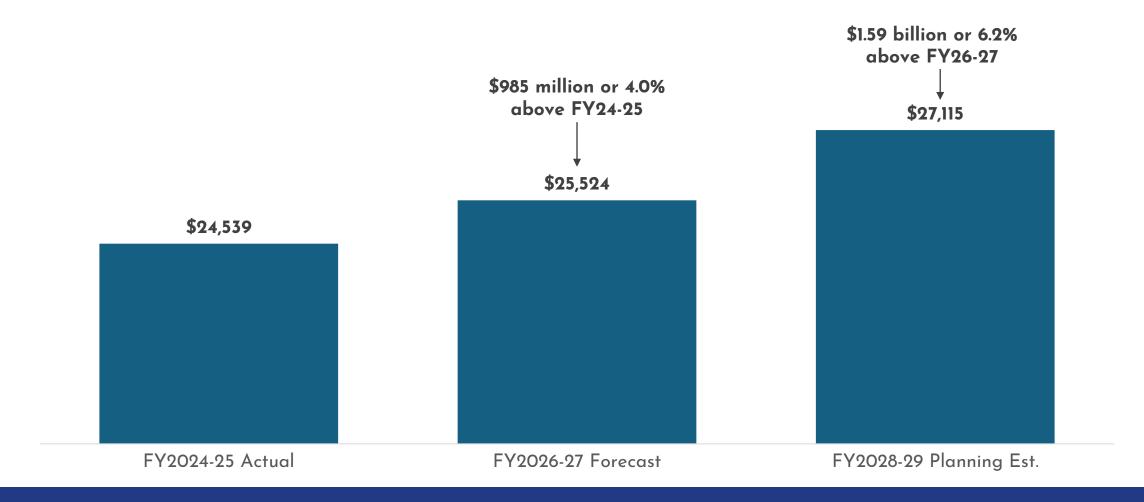
### E-12 Education General Fund Budget

FY2026-27 Base Budget: \$25.5 billion, 38.6% of all General Fund expenditures

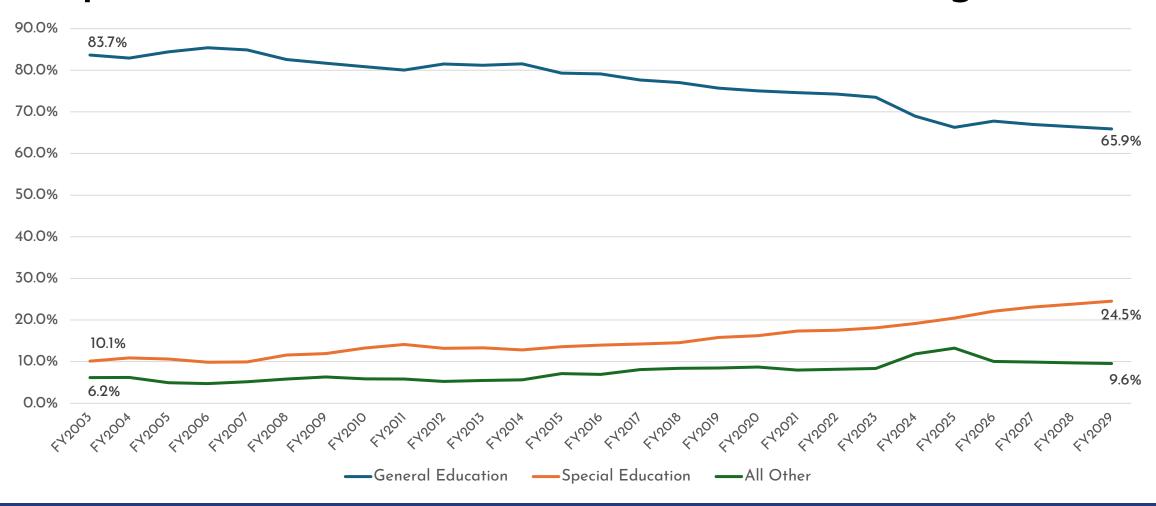

#### Basic Formula Allowance Forecast

Beginning in FY2026, the formula allowance is increased annually by the greater of two percent or the rate of inflation, not to exceed three percent. The amounts for FY2026-29 are estimates.

Fiscal Year	Formula Allowance	Forecasted Inflation Adjustment
2024	\$7,138	N/A
2025	\$7,281	N/A
2026	\$7,448	2.29%
2027	\$7,636	2.52%
2028	\$7,856	2.89%
2029	\$8,013	2.00%
