## "Section 1. ACADEMIC ACCELERATION PILOT PROGRAM.

- Subdivision 1. Pilot program established. The commissioner of education must establish a pilot program to increase access to rigorous coursework in six school districts or charter schools during the 2026-2027 to 2028-2029 school years.
- 1.7 <u>Subd. 2.</u> <u>**Definitions.**</u> (a) For purposes of this section, the following terms have the meanings given them.
- (b) "Rigorous coursework" means an advanced placement course, postsecondary
