1.24 2003, may not expend the reserved funds for future reemployment expenditures. Each year
1.25 a levy reduction must be made to return these funds to taxpayers. The amount of the levy

2.6 purposes for any week during the period between two successive academic years or terms
2.7 if:

2.8 (1) the applicant had employment for an educational institution or institutions in the
2.9 prior academic year or term; and

2.10 (2) there is a reasonable assurance that the applicant will have employment for an
2.11 educational institution or institutions in the following academic year or term.

2.12 This paragraph applies to a vacation period or holiday recess if the applicant was
2.13 employed immediately before the vacation period or holiday recess, and there is a reasonable
2.14 assurance that the applicant will be employed immediately following the vacation period
2.15 or holiday recess. This paragraph also applies to the period between two regular but not
2.16 successive terms if there is an agreement for that schedule between the applicant and the
2.17 educational institution.

2.18 This paragraph does not apply if the subsequent employment is substantially less
2.19 favorable than the employment of the prior academic year or term, or the employment prior
2.20 to the vacation period or holiday recess.

2.21 (b) Paragraph (a) does not apply to ~~any week during the period between two successive~~

2.23 of the prior academic year or term, had an agreement for a definite period of employment
2.24 between academic years or terms in other than instructional, research, or principal
2.25 administrative capacity and the educational institution or institutions failed to provide that
2.26 employment.

2.27 (c) ~~Paragraph (a) applies to a vacation period or holiday recess if the applicant was~~
2.28 ~~employed immediately before the vacation period or holiday recess, and there is a reasonable~~
2.29 ~~assurance that the applicant will be employed immediately following the vacation period~~
2.30 ~~or holiday recess, including applicants who worked in a capacity other than instructional,~~
2.31 ~~research, or principal administrative capacity.~~ If unemployment benefits are denied to any
2.32 applicant under paragraph (a) who was employed in the prior academic year or term in other

3.8 service agency" means a governmental entity established and operated for the purpose of
3.9 providing services to one or more educational institutions.

3.10 (e) This subdivision applies to employment with Minnesota, a political subdivision, or
3.11 a nonprofit organization, if the services are provided to or on behalf of an educational
3.12 institution or institutions.

3.13 (f) Paragraph (a) applies beginning the Sunday of the week that there is a reasonable
3.14 assurance of employment.

3.15 (g) Employment and a reasonable assurance with multiple education institutions must
3.16 be aggregated for purposes of application of this subdivision.

3.17 (h) If all of the applicant's employment with any educational institution or institutions
3.18 during the prior academic year or term consisted of on-call employment, and the applicant
3.19 has a reasonable assurance of any on-call employment with any educational institution or
3.20 institutions for the following academic year or term, it is not considered substantially less
3.21 favorable employment.

3.22 (i) A "reasonable assurance" may be written, oral, implied, or established by custom or
3.23 practice.

3.24 (j) An "educational institution" is a school, college, university, or other educational entity
3.25 operated by Minnesota, a political subdivision or instrumentality thereof, or a nonprofit
3.26 organization.

3.27 (k) An "instructional, research, or principal administrative capacity" does not include
3.28 an educational assistant.

3.29 **EFFECTIVE DATE.** This section is effective the day following final enactment.

4.8 performed by its employees.

4.11 work under a contract between the employer and an elementary or secondary school; and

4.12 (2) the employment was related to food services provided to the school by the employer.
