Minn. Stat. § 15.0145

Subdv. 6. Duties of council.


"(a) A council must work for the implementation of economic, social, legal, and political equality for its constituency."

Key Provisions:

- ➤ 15-member voting board
 - > 11 community members appointed by the Governor
 - > 4 legislative members appointed by legislative leadership
- Advise the Governor and the Legislature on issues confronting the constituency of the Council
- Advocate for administrative and legislative changes needed to improve the economic and social condition of the constituency of the Council
- > Serve as a liaison between state government and organizations that serve the constituency of the Council








Current Budget Overview




Historical Spending by Biennium

The Council's Work

The Council undertakes numerous initiatives each year to fulfill its statutory role as advisor, advocate, and liaison:

- ➤ Produces original research to provide clear, up-to-date understanding of Asian Pacific Minnesotans (APMs)
- ➤ Advises on legislative and administrative policies and practices
- > Facilitates relationships between legislators and APM communities
- > Provides logistical support to Asian-led community-based organizations



The Council's Impact

As a result of the Council's work, our communities are better off for the following:

- ➤ Issued the 2024 Community Priorities Survey to identify policy issues of greatest concern to the APM population
- ➤ Initiated legislative requests for funding to commemorate the 50th anniversary of the Vietnam War and convened more than 20 planning meetings with Minnesota's Cambodian, Lao, and Vietnamese communities to ensure authentic representation in funding requests and commemorative activities
- ➤ Hosted over 700 guests at the 2024 Asian Pacific Minnesotans Leadership Awards Dinner to honor the contributions of APMs to our state and nation
- Liaised with foreign consulates and dignitaries on issues of importance to APM communities including justice, democracy, economic development, trade relations, sister cities, and more
- > Coordinated with Asian faith leaders, law enforcement, state government, and the federal Department of Justice in response to organized criminal activity targeting Asian-led places of worship

Legislative Priorities

The Council determines its legislative agenda through community input:

- Community events

- Access to Healthcare
- > Arts, Culture, and Heritage
- Income and Wages
- ➤ Home Ownership
- Employment



The Council's Ask

The Council requests an increase over its base budget in FY26-27 to:

- Meet the growing needs of Minnesota's API communities and bring the Council into parity with other ethnic councils through the addition of 1 FTE, a *Special Projects Coordinator*
- > Retain contractors with specific skillsets
- > Strengthen relationships with Asian Pacific communities in greater Minnesota
- ➤ Build on existing bodies of original research
- > Account for increased businesses expenses
