

**Senator Xiong from the Committee on State and Local Government, to which was referred**

**S.F. No. 1581:** A bill for an act relating to state government; applying nonstate funding for implementation of the Capitol Mall Design Framework; appropriating money to improve livability in the Capitol Area and to support grantmaking for community vitality grants; repealing Laws 2023, chapter 53, article 17, section 2.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. Laws 2023, chapter 62, article 1, section 11, subdivision 2, is amended to read:

Subd. 2. <b>Government and Citizen Services</b>	39,928,000	19,943,000

The base for this appropriation is \$17,268,000 in fiscal year 2026 and \$17,280,000 in fiscal year 2027.

**Council on Developmental Disabilities.**  
\$222,000 each year is for the Council on Developmental Disabilities.

**State Agency Accommodation Reimbursement.** \$200,000 each year may be transferred to the accommodation account established in Minnesota Statutes, section 16B.4805.

**Disparity Study.** \$500,000 the first year and \$1,000,000 the second year are to conduct a study on disparities in state procurement. This is a onetime appropriation.

**Grants Administration Oversight.**  
\$2,411,000 the first year and \$1,782,000 the second year are for grants administration oversight. The base for this appropriation in fiscal year 2026 and each year thereafter is \$1,581,000.

\$735,000 the first year and \$201,000 the second year are for a study to develop a road map on the need for an enterprise grants

2.1 management system and to implement the  
2.2 study's recommendation. This is a onetime  
2.3 appropriation.

2.4 **Risk Management Fund Property**

2.5 **Self-Insurance.** \$12,500,000 the first year is  
2.6 for transfer to the risk management fund under  
2.7 Minnesota Statutes, section 16B.85. This is a  
2.8 onetime appropriation.

2.9 **Office of Enterprise Translations.**

2.10 \$1,306,000 the first year and \$1,159,000 the  
2.11 second year are to establish the Office of  
2.12 Enterprise Translations. \$250,000 each year  
2.13 may be transferred to the language access  
2.14 service account established in Minnesota  
2.15 Statutes, section 16B.373.


2.16 **Capitol Mall Design Framework**

2.17 **Implementation.** \$5,000,000 the first year is  
2.18 to implement the updated Capitol Mall Design  
2.19 Framework, prioritizing the framework plans  
2.20 identified in article 2, section 124. This  
2.21 appropriation is available until ~~December 31,~~  
2.22 2024 June 30, 2026.

2.23 **Parking Fund.** \$3,255,000 the first year and  
2.24 \$1,085,000 the second year are for a transfer  
2.25 to the state parking account to maintain the  
2.26 operations of the parking and transit program  
2.27 on the Capitol complex. These are onetime  
2.28 transfers.

2.29 **Procurement; Environmental Analysis and**

2.30 **Task Force.** \$522,000 the first year and  
2.31 \$367,000 the second year are to implement  
2.32 the provisions of Minnesota Statutes, section  
2.33 16B.312.
