BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. [256.4931] COUNCIL ON DIRECT SUPPORT PROFESSIONALS.

Subdivision 1. **Establishment.** The council on direct support professionals is established to develop a statewide strategic plan to address the shortage of direct support professionals and to promote improvement in the availability of direct support services in all areas of the state.

- Subd. 2. **Definitions.** (a) For the purposes of this section, the terms in this subdivision have the meanings given.
- (b) "Direct support professional" means any individual who is not a licensed health professional and is qualified to provide direct support services, including individuals who are qualified to be personal care assistants, home health aides, nursing assistants, resident assistants, or direct support staff.
- (c) "Direct support services" means assistance with activities of daily living; assistance with instrumental activities of daily living; providing home and community-based services; and other similar, long-term services and supports provided to a person age 65 or older or to a person with a disability by a direct support professional to meet the person's daily living needs and ensure that the person may adequately function in the person's home and have safe access to the community.

The executive director serves as an ex officio nonvoting member of the executive committee and shall provide administrative support for the council; provide administrative leadership to implement council mandates, policies, and objectives; and employ and direct staff authorized according to state law and necessary to carry out council mandates, policies, activities, and objectives. The council may delegate to the executive director any powers and duties under this section that do not require council approval. The salary of the executive director and staff must be established pursuant to chapter 43A.
