Subject: Request for Support in Expanding Ramsey County HRA to Include Economic Development Authority Functions – HF 2349 (Lee) / SF 2521 (Hawj)

Dear Chair Xiong:

I am writing to inform you that the City of Roseville, as part of its adopted Legislative Priorities, supports Ramsey County's effort to expand the statutory authority of the Ramsey County Housing and Redevelopment Authority (HRA) to include economic development activities through the establishment of an Economic Development Authority (EDA) as proposed in HF 2349/SF 2521.

The City of Roseville supports fostering a thriving business environment, helping emerging entrepreneurs, and diversifying industries both in Roseville and across our communities in Ramsey County. The proposed legislative change would allow for small business programming to be included as an eligible use of the existing HRA levy, without creating a new taxing authority. It is important to note that Roseville's support of Ramsey County's request is based on the fact that no new taxing authority will be created with this legislation.

The expansion to an EDA would enable the County to better support local businesses through enhanced technical assistance, capacity building for business support organizations, and access to additional flexible capital.
