Vice Chair Maye Quade moved the 8A amendment. **MOTION PREVAILED.** THE AMENDMENT WAS ADOPTED.


Senator Maye Quade moved that S.F. 2884, as amended, recommended to pass and re-referred to the Finance Committee. - **MOTION PREVAILED.**
