Trunk Highway 610 & East River Road Full Access Interchange



FUNDING REQUEST:

\$10 Million in Trunk Highway Bonds

To construct a full access interchange at Trunk Highway (TH) 610 and East River Road in Coon Rapids.

PURPOSE & NEED



Access

- » Coon Rapids only has "half" an interchange system on TH 610 the project would complete the existing interchange at East River Road.
- » There are currently **NO westbound exits OR eastbound on ramps** along TH 610 in the city between the Coon Rapids/Blaine border to the Mississippi River.
- » Direct access from TH 610 to East River Road and Coon Rapids Boulevard is only available when traveling east.

About 15% of freight trips from TH 610 coming to the area are traveling west.



Safety

- » Not having an eastbound on ramp option on TH 610 impacts emergency response teams.
- » Coon Rapids Police and Fire must travel across the Mississippi River outside city limits and then turn around to get to eastbound travelers. Brooklyn Park is often called for immediate assistance as they can get there faster.
- » Access is especially difficult between University Avenue and the Mississippi River.

Coon Rapids police and fire departments respond to an average of 190 emergency calls to this area each year.




Functionality

- » Westbound drivers must use long and confusing local routes such as Foley Boulevard or University Avenue, which add time and miles to every trip.
- » This adds congestion at other interchanges and creates backups on local routes.
- » Local routes (designed for low speed and low volume) experience significant semi truck traffic and backups in front of driveways and through pedestrian areas.


Traveling westbound without an exit can add 5 MILES of out-of-direction travel and more than 6 MINUTES to each trip!

Existing Access for TH 610 in Coon Rapids


