1.6	Section 1. DRIVER'S EDUCATION FINANCIAL ASSISTANCE PILOT PROGRAM.
1.7	Subdivision 1. <b>Definitions.</b> (a) For purposes of this section, the following terms have
1.8	the meanings given.
1.9	(b) "Commissioner" means the commissioner of public safety.
1.10	(c) "Eligible entities" means a school district; city; county; town; local government unit;
1.11	federally recognized Tribe, as defined in United States Code, title 25, section 5304(e); or
1.12	nonprofit organization providing or seeking to provide assistance to low-income or
1.13	disadvantaged youth.
1.14	(d) "Eligible youth" means a person who is at least 15 years of age and not more than
1.15	24 years of age and meets one of the criteria specified in subdivision 4, paragraph (c).
1.16	(e) "Driver's education" means a public driver's education course offered by a public

1.21	Subd. 2. Pilot program established. A driver's education financial assistance pilot
1.22	program is established in the Department of Public Safety to award grants to eligible entities

to expand access and availability to driver's education courses and drivers' licenses for

eligible youth ages 15 to 24. 2.2 Subd. 3. Account established; eligible expenditures. (a) A driver's education financial 2.3 assistance account is created in the special revenue fund in the state treasury. The 2.4 commissioner must credit to the account appropriations and transfers to the account. Earnings, 2.5 including interest, dividends, and any other earnings arising from assets of the account, 2.6 must be credited to the account. Money in the account at the end of the fiscal year does not 2.7 cancel to the general fund but remains available in the account until expended. 2.8 (b) Money in the account must be used only to: 2.9 (1) award grants to eligible organizations under this section; and 2.10 (2) reimburse the Department of Public Safety's reasonable costs for administrative and 2.11 staffing expenses. 2.12 Subd. 4. Eligibility. (a) The commissioner must establish the driver's education financial 2.13 pilot program and coordinate its operation with eligible entities. Upon a successful 2.14 application, a participating eligible entity may award an eligible youth financial assistance 2.15 as provided under this section. The commissioner must establish the pilot program in at 2.16 least one urban, rural, suburban, and Tribal community and make extensive efforts to 2.17 publicize the pilot program and how the funds may be used. Su	abd. 5. <b>Program administration.</b> (a) The commissioner must establish a referral
systen	n to administer the pilot program. The referral system must be operated by an
intern	nediary selected by the commissioner and identify a community-driven approach to
ensure	e eligible youth have access and support to complete the driver's license process.
Entitie	es seeking to participate in the pilot program must have the support of school districts
and co	ommunity-based organizations that focus on under-served and low-income populations
and id	lentify and establish an application procedure to recruit, obtain, and support up to 200
eligib	le youth in the pilot program per location. An intermediary selected under this section
by the	e commissioner is eligible for reimbursement for the costs of administering and
operat	ting the pilot program, not to exceed \$100,000.

(a) Participating eligible entities must keep records of financial assistance awarded to individuals and all expenses associated with appropriated money. 4.6 (b) Participating eligible entities must not exceed 15 percent of the total appropriation 4.7 for administrative costs. 4.8 Subd. 7. Data collection and outcomes. 5.10	The report must describe the status of driver education courses in Minnesota and recommend
5.11	changes to increase student access to driver education courses. The report must also
5.12	recommend a permanent funding mechanism to expand the availability of driver education

5.14	(d) Public members of the work group, except the eligible youth appointed to the

5.24	\$3,850,000 in fiscal year 2026 is appropriated from the general fund to the commissioner
