1.3 **S.F. No. 1786:** A bill for an act relating to children and families; modifying relative  
1.4 foster care licensing, training, and background study requirements; modifying the Minnesota  
1.5 family investment program; appropriating money; amending Minnesota Statutes 2024,  
1.6 sections 142B.01, subdivision 15; 142B.05, subdivision 3; 142B.47; 142B.51, subdivision  
1.7 2; 142B.80; 142E.01, subdivisions 14, 19; 142G.01, subdivision 8; 142G.40, subdivision  
1.8 4; 245C.02, by adding a subdivision; 245C.03, subdivision 1; 245C.08, subdivision 1;  
1.9 245C.15, by adding a subdivision; proposing coding for new law in Minnesota Statutes,  
1.10 chapter 142B.

1.15 Page 11, line 23, after the second semicolon, insert "609.20 (manslaughter in the first  
1.16 degree); 609.205 (manslaughter in the second degree); 609.2112 (criminal vehicular  
1.17 homicide);"

1.18 Page 11, line 28, after the second semicolon, insert "609.247, subdivision 2 or 3  
1.19 (carjacking in the first or second degree);" and before "609.2661" insert "609.255 (false  
1.20 imprisonment);"

1.21 Page 12, line 6, after the first semicolon, insert "609.3458 (sexual extortion);"

1.22 Page 12, line 7, after the second semicolon, insert "609.561 (arson in the first degree);"

1.23 Page 12, line 8, after the first semicolon, insert "609.746 (interference with privacy);"

1.24 Page 13, line 3, delete "609.20"

1.25 Page 13, delete line 4

1.26 Page 13, line 5, delete everything before "609.2113"

1.27 Page 13, line 6, after the second semicolon, insert "609.221 (assault in the first degree);"

1.28 Page 13, line 9, delete "2, 3, or"

1.29 Page 13, line 10, delete "first, second, or" and delete "609.255 (false imprisonment);"

1.30 Page 13, line 13, delete everything after the semicolon

1.31 Page 13, line 14, delete everything before "609.562"


1.32 Page 13, line 16, delete "609.746 (interference with privacy);"

- 2.3Reletter the paragraphs in sequence
- 2.4Page 15, line 3, delete "(d)" and insert "(c)"
