

1.1 Senator moves to amend S.F. No. 1232 as follows:

1.2 Page 1, after line 4, insert:

1.3 "Section 1. Minnesota Statutes 2024, section 142B.77, is amended to read:

1.4 **142B.77 SUPERVISION OF FAMILY CHILD CARE LICENSE HOLDER'S OWN**
1.5 **CHILD OR CHILDREN.**

1.6 (a) ~~Notwithstanding Minnesota Rules, part 9502.0365, subpart 5, and~~ With the license
1.7 holder's consent, an individual may be present in the licensed space, may supervise and care
1.8 for the family child care license holder's own child both inside and outside of the licensed
1.9 space, and is exempt from the training and supervision requirements of this chapter and
1.10 Minnesota Rules, chapter 9502, if the individual:

1.11 (1) is related to the license holder or to the license holder's child, as defined in section
1.12 142B.01, subdivision 15, or is a household member who the license holder has reported to
1.13 the county agency;

1.14 (2) is not a designated caregiver, helper, or substitute for the licensed program at the
1.15 time that they are supervising the license holder's own child;

1.16 (3) is involved only in the care of the license holder's own child; and

1.17 (4) does not have direct, unsupervised contact with any nonrelative children ~~receiving~~
1.18 services in care.

1.19 (b) If the individual in paragraph (a) is not a household member, the individual is also
1.20 exempt from background study requirements under chapter 245C.

1.21 (c) The entirety of this chapter applies during hours of operation, including when
1.22 caregivers care for their own children of child care age in the program, except as provided
1.23 in paragraph (d).

1.24 (d) The following rules do not apply to caregivers with regards to the care of their own
1.25 children of child care age in the program:

1.26 (1) Minnesota Rules, part 9502.0395 (behavior guidance);

1.27 (2) Minnesota Rules, part 9502.0405, subpart 5 (children with special health needs or
1.28 disabilities);

1.29 (3) Minnesota Rules, part 9502.0415 (activities and equipment); and

1.30 (4) Minnesota Rules, part 9502.0443 (food and nutrition).

2.1 (e) The exceptions identified in paragraph (d) do not exempt the caregiver from the
2.2 applicability of other requirements found in chapter 260E on maltreatment of minors, chapter
2.3 609 on criminal code, and other related laws.

2.4 (f) The exceptions identified in paragraph (d) do not exempt the agency from enforcing
2.5 these standards when the caregiver's actions in regard to their own child affect the other
2.6 children in care."
