APPROPRIATION FOR WORKFORCE HOUSING DEVELOPMENT. 1.5 Subdivision 1. **Appropriation.** \$5,000,000 in fiscal year 2026 is appropriated from the 1.6 general fund to the commissioner of the Minnesota Housing Finance Agency for a grant to 1.7 the Center for African Immigrants and Refugees Organization (CAIRO) for the construction 1.8 1.9 of 70 units of workforce housing as part of the Iskufilan Village development in St. Cloud, Minnesota. The purpose of the project is to provide safe, modern, and affordable housing 1.10 for low-income and middle-income families that are frontline workers. This is a onetime 1.11 appropriation. Any amount encumbered under contract on or before June 30, 2025, is 1.12 available until June 30, 2027. 1.13 Subd. 2. Authorized expenditures.
