A bill for an act 1.1 relating to human services; converting the Governor's Council on an Age-Friendly 1 2 Minnesota into the Age-Friendly Minnesota Council; codifying existing grants; 1.3 appropriating money; amending Laws 2021, chapter 30, article 12, section 5, as 1.4 amended; proposing coding for new law in Minnesota Statutes, chapter 256. 1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.6 Section 1. [256.9746] AGE-FRIENDLY MINNESOTA COUNCIL. 1.7 Subdivision 1. Establishment. The Age-Friendly Minnesota Council is established to 1.8 coordinate work across sectors, including state government, nonprofits, communities, 1.9 businesses, and others, to ensure the state is an age-friendly state. 1.10 Subd. 2. **Membership.** (a) The council consists of 15 voting members. 1.11 (b) Each of the following commissioners and multimember state agencies must designate 1.12 an Age-Friendly Minnesota lead and appoint that designee to serve as a council member: 1.13 (1) the Minnesota Board on Aging; 1.14 (2) the commissioner of commerce; 1.15 (3) the commissioner of employment and economic development; 1.16 (4) the commissioner of health; 1.17 1.18 (5) the commissioner of housing; (6) the commissioner of human services; 1.19 1.20 (7) the commissioner of transportation;

(8) the commissioner of veterans affairs; and

(9) the Metropolitan Council. 2.1 (c) The governor shall appoint six additional public members to represent older adults 2.2 in communities experiencing disparities, direct service caregivers, businesses, experts on 2.3 aging, local governments, and Tribal communities. The appointment, terms, compensation, 2.4 2.5 and removal of public members shall be as provided in section 15.059. (d) Other state agencies and boards may participate on the council in a nonvoting capacity. 2.6 Subd. 3. Chairperson; executive committee. (a) The council shall elect a chairperson 2.7 and other officers as it deems necessary and in accordance with the council's operating 2.8 procedures. 2.9 (b) The council shall be governed by an executive committee elected by the members 2.10 of the council. One member of the executive committee must be the council chairperson. 2.11 (c) The executive committee may appoint additional subcommittees and work groups 2.12 as necessary to fulfill the duties of the council. 2.13 2.14 Subd. 4. **Meetings.** (a) The council shall meet at the call of the chairperson or at the request of a majority of council members. The council must meet at least quarterly. Meetings 2.15 of the council are subject to section 13D.01, and notice of its meetings is governed by section 2.16 13D.04. 2.17 (b) Notwithstanding section 13D.01, the council may conduct a meeting of its members 2.18 by telephone or other electronic means so long as: 2.19 (1) all members of the council participating in the meeting, wherever their physical 2.20 location, can hear one another and can hear all discussion and testimony; 2.21 (2) members of the public present at the regular meeting location of the council can hear 2.22 all discussion and all votes of members of the council and participate in testimony; 2.23 2.24 (3) at least one member of the council is physically present at the regular meeting location; and 2.25 (4) each member's vote on each issue is identified and recorded by a roll call. 2.26 Each member of the council participating in a meeting by telephone or other electronic 2.27 means is considered present at the meeting for the purposes of determining a quorum and 2.28 participating in all proceedings. If telephone or another electronic means is used to conduct 2.29 a meeting, the council, to the extent practicable, shall allow a person to monitor the meeting 2.30 from a remote location. If telephone or another electronic means is used to conduct a regular, 2.31 special, or emergency meeting, the council shall provide notice of the regular meeting 2.32
