BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Laws 2023, chapter 61, article 1, section 5, the effective date, is amended to

The commissioner of human services shall notify the revisor of statutes when federal approval is obtained.

Sec. 7. **ADVISORY TASK FORCE ON FAMILY RESIDENTIAL SERVICES.**

Subdivision 1. **Establishment; purpose.** The Advisory Task Force on Family Residential Services is established to evaluate proposed family residential services rate modifications and the impact any proposed payment methodology would have on existing family residential services and licensed adult family foster care providers.

Subd. 2. **Membership.** (a) The Advisory Task Force on Family Residential Services must consist of the members appointed as follows:

(1) two licensed adult family foster care providers, appointed by the commissioner of human services;

(2) two licensed adult family foster care providers, appointed by ARRM;

(3) one member representing the Department of Human Services who has experience with adult family foster care providers and family residential services, appointed by the commissioner of human services;

(4) one member representing the Department of Human Services who has experience with disability waiver rate setting, appointed by the commissioner of human services;

(5) one member representing lead agencies, appointed by the Association of Minnesota Counties;

3.1 (6) one member representing ARRM, appointed by ARRM;

3.2 (7) one member receiving services through adult family foster care, appointed by the
3.3 commissioner of human services; and

3.4 (8) one member receiving life sharing services, appointed by the commissioner of human
3.5 services.

3.6 (b) Appointments must be made no later than January 1, 2026.

3.7 (c) Notwithstanding Minnesota Statutes, section 15.059, subdivision 6, member
3.8 compensation and reimbursement for expenses are governed by Minnesota Statutes, section
3.9 15.059, subdivision 3.

3.10 Subd. 3. **Meetings.** (a) The commissioner of human services must convene the first
3.11 meeting of the advisory task force no later than March 1, 2026.

3.12 (b) Advisory task force meetings are subject to the open meeting law under Minnesota
3.13 Statutes, chapter 13D.

3.14 (c) Advisory task force meetings must be conducted by telephone or interactive
3.15 technology according to Minnesota Statutes, section 13D.015.

3.16 Subd. 4. **Administrative support.** (a) The commissioner of human services must provide
3.17 administrative support and staff assistance for the advisory task force.

3.18 (b) The commissioner of human services must provide the advisory task force with data,
3.19 fiscal estimates, rate models, draft waiver amendments, implementation updates, estimated
3.20 impacts, and other information the advisory task force requires to fulfill its duties under
3.21 subdivisions 5 and 6.

3.22 Subd. 5. **Duties.** (a) Prior to issuing the report required under subdivision 6, paragraph
3.23 (a), the advisory task force must evaluate multiple family residential service rate models
3.24 and the impact the proposed rate models would have on family residential services and adult
3.25 family foster care providers. The evaluations must include:

3.26 (1) case studies demonstrating rate changes adult family foster care providers will
3.27 experience under each rate model;

3.28 (2) an estimate of the median rate change for family residential services adult family
3.29 foster care providers will experience under each rate model;

3.30 (3) the number of adult family foster care providers operating in Minnesota; and

4.1 (4) the number of individuals receiving family residential services from licensed adult
4.2 family foster care providers.

4.3 (b) Prior to issuing the report required under subdivision 6, paragraph (b), the advisory
4.4 task force must monitor the development and implementation of the family residential
4.5 service rate methodology and the impact of the rate methodology on family residential
4.6 services and adult family foster care providers.

4.7 Subd. 6. **Reports.** (a) No later than August 1, 2027, the advisory task force must submit
4.8 to the chairs and ranking minority members of the legislative committees with jurisdiction
4.9 over licensed adult foster care providers and family residential services reimbursement rates
4.10 a written report that includes recommendations on:

4.11 (1) a payment rate methodology for family residential services;

4.12 (2) a payment rate methodology for life sharing services;

4.13 (3) any additional recommended changes to family residential services and life sharing
4.14 services;

4.15 (4) any legislative changes required to implement the recommendations of the advisory
4.16 task force; and

4.17 (5) any legislative modifications to the duties or authorities of the advisory task force
4.18 required to adequately monitor the implementation of new rates for family residential
4.19 services and life sharing services.

4.20 (b) No later than January 15, 2030, the advisory task force must submit to the chairs and
4.21 ranking minority members of the legislative committees with jurisdiction over licensed
4.22 adult foster care providers and family residential services reimbursement rates a written
4.23 report that includes an assessment of the development and implementation of the family
4.24 residential service rate methodology and the impact of the rate methodology on family
4.25 residential services and adult family foster care providers.

4.26 Subd. 7. **Expiration.** The advisory task force expires June 30, 2030.

4.27 **EFFECTIVE DATE.** This section is effective July 1, 2025.

4.28 Sec. 8. **APPROPRIATION; ADVISORY TASK FORCE ON FAMILY**
4.29 **RESIDENTIAL SERVICES.**
