TRAINING PROGRAM: WE PROVIDED FULL-TIME EMPLOYMENT OPPORTUNITIES FOR A TOTAL OF 43 PROGRAM PARTICIPANTS WITH 13 PHASE 1 GRADUATES (COMPLETING 500 HOURS) AND 15 PHASE 2 GRADUATES COMPLETING OUR 18 MONTH WORKFORCE DEVELOPMENT PROGRAM. 70% OF OUR PHASE 2 GRADUATES TRANSITIONED TO STABLE LONG-TERM EMPLOYMENT WITHIN OUR ORGANIZATION OR OUTSIDE OF JOBS FOUNDATION. OUR ON THE JOB TRAINING PROGRAM PROVIDED OVER \$650K IN PAID WAGES TO INDIVIDUALS FACING BARRIERS TO EMPLOYMENT.
