Dear Chair Champion and Committee Members,

We represent some of the 41 organizations that are current program partners with the Department of Employment and Economic Development (DEED) to deploy technical assistance to entrepreneurs and small businesses through the Small Business Assistance Partnerships program. For 14 years, this proven program has been helping small businesses succeed and it has a huge economic return on investment for local communities and the state as a whole.

Collectively, we are writing to ask for your support for the Small Business Assistance Partnerships program at the Department of Employment and Economic Development (DEED). Because the base funding for this program is significantly lower than the investment made in 2023, \$7.4 million will fill the funding gap for the 2026-2027 biennium. This funding is critical to the continuation of delivering free, high-quality technical assistance to small businesses across Minnesota.

Small Businesses helped by the Small Business Assistance Partnerships program funding include grocery stores, small farms, construction companies, childcare businesses, dentists, restaurants, event centers, salons, veterinarian clinics, indoor play centers and so many more. We believe in this program because of its statewide impact, job creation and economic growth.

- **Statewide Impact:** Because our organizations are located throughout Minnesota collectively, we are able to serve every corner of the state. Our organizations are trusted community partners with unique relationships and skills that understand how to best meet the needs of our communities.
