1.6	Section 1. Minnesota Statutes 2024, section 609.50, subdivision 1, is amended to read:
1.7	Subdivision 1. Crime. (a) Whoever intentionally does any of the following may be
1.8	sentenced as provided in subdivision 2:
1.9	(1) obstructs, hinders, or prevents the lawful execution of any legal process, civil or
1.10	criminal, or apprehension of another on a charge or conviction of a criminal offense;
1.11	(2) obstructs, resists, or interferes with a peace officer while the officer is engaged in
1.12	the performance of official duties;
1.13	(3) interferes with or obstructs a firefighter while the firefighter is engaged in the
1.14	performance of official duties;
1.15	(4) interferes with or obstructs a member of an ambulance service personnel crew, as
1.16	defined in section 144E.001, subdivision 3a, who is providing, or attempting to provide,
1.17	emergency care; or
1.18	(5) by force or threat of force endeavors to obstruct any employee of the Department of
1.19	Revenue, Department of Public Safety Driver and Vehicle Services Division, a driver's

2.1	(b) It is a crime punishable as provided in subdivision 2 for someone to approach or
2.2	remain within 25 feet of a person described in paragraph (a), clause (2), (3), or (4):
2.3	(1) while knowing or having reason to know of the person's status and that the person
2.4	is engaged in the lawful performance of a legal duty;
2.5	(2) after having received a verbal warning from the person not to approach; and
2.6	(3) with the intent to impede or interfere with the person's ability to perform the legal
2.7	duty.
2.8	EFFECTIVE DATE. This section is effective August 1, 2025, and applies to crimes
2.9	committed on or after that date.
