Subject: Support for S.F. 2735 – Abandoned boats removal and disposal requirement

Dear Chair Latz and members of the Senate Judiciary Committee,

Furthermore, the provisions that void licenses for those convicted will underscore the importance of adhering to state laws, which will ultimately benefit individuals and businesses engaged in recreational boating.

Our organization recognizes the value of maintaining the state's lakes and rivers as vibrant ecosystems that support both recreational activities and local economies. By coordinating with neighboring jurisdictions, S.F. 2735 strengthens the overall effort to address abandoned boats on boundary waters, ensuring that Minnesota's environmental standards align with those of its neighbors.
