S.F. 856: Senator Gustafson: Office of the Inspector General creation and appropriation.

Senator Frentz moved the A47 amendment. THE **MOTION PREVAILED**.

Page 1, line 5 after the period, insert the following sentence "Section 15.066 subdivision 3 does not apply."
