S.F. 455: Senator Nelson – Nonprofit outpatient rehabilitation clinics sales and use tax exemption authorization


Senator Nelson offered the A-2 amendment, the motion prevailed, and the amendment was adopted.

Senator Rest moved that S.F. 455 be laid over


