
STATEMENT OF NEED AND
REASONABLENESS

The need to repeal this rule arises because Laws 1976 - Chapter 305, as amended, authorizing appropriations for the Pilot Dental Health Program, expired effective June 30, 1980. All requirements of the law, as amended have been met as evidenced by the report to the Legislature entitled Final Report to the 1980 Minnesota State Legislature on the Pilot Dental Care Program for Senior Citizens. Rule 59 was initially established to implement the above law.

Rule 59 will be repealed five (5) working days after publication of the final notice in the State Register.


STATEMENT OF NEED AND

RECORDS


STATEMENT OF NEED
AND REASONABLENESS

The need to repeal this rule is the result of the enactment into law of the substance of the rule. The privacy protection of public assistance records has been incorporated into statute by Minnesota Statutes §15.1691. The safeguards against disclosure of information concerning recipients of welfare and procedures relating to the administration of government records have been incorporated into Minnesota Statutes §§15.1611 to 15.17.

Rule 45 will be repealed five (5) working days after publication of the final notice in the State Register.
