STATEMENT OF NEED AND REASONABLENESS

PROPOSED CONSOLIDATED GAME AND FISH RULES

MINNESOTA DEPARTMENT OF NATURAL RESOURCES

APRIL 1993

Part 1. Commissioner's Order Legislation.

a) 1991 Legislation.

In 1991, legislation passed which phased out the Department of Natural Resources' use of commissioner's orders to promulgate game and fish regulations. Laws of 1991, Chapter 259 removed the exemption, effective July 1, 1992, of commissioner's orders from the Minnesota Statutes, Chapter 14 Administrative Procedure Act. In its place, a hybrid version of the emergency rule process was established in Minnesota Statutes, section 14.29. This hybrid version of the emergency rule process prescribes the process in which the department may promulgate its annual game and fish regulations in a timely and effective manner. Language promulgated under this process, unlike other emergency rules, can remain in effect for up to 18 months but may only be utilized for rules, which are authorized under Minnesota Statutes, Chapters 97A, 97B, and 97C, for the following purposes:

- a) to set open seasons and areas;
- b) to close open seasons and areas;
- c) to select hunters for areas;
- d) to provide for tagging and registration of game;
- e) to prohibit or allow taking of wild animals to protect a species; and
- f) to prohibit or allow importation, transportation, or possession of a wild animal.

Language that does not fall into one of these categories must be promulgated through use of the standard rulemaking provisions of the Administrative Procedures Act. The legislation specified that any commissioner's orders that have not been adopted under the Administrative Procedure Act expire as of July 1, 1993. Finally, the legislation provided a time period for the department to make recommendations to the legislature regarding orders that should be exempted from the rulemaking requirements.

b) 1992 Legislation.

In 1992, the second piece of the commissioner's order conversion process passed the legislature. Laws of 1992, Chapter 462 provided clarification for certain rulemaking authority for the commissioner relating to language that existed in commissioner's order. The legislation also added the following categories to the list of items that may be promulgated through the use of the hybrid emergency rule process:

- a) to set seasons for harvesting wild ginseng roots and to restrict or prohibit harvesting in designated areas; and
- b) to set seasons for harvesting wild rice and to restrict or prohibit harvesting in designated areas.

c) 1993 Legislation.

Legislation has been introduced in the 1993 legislature (SF 963/HF 898) that provides for the codification of commissioner's order language into permanent rule and clarifies/creates the remaining rulemaking authority statutory provisions for language previously

existing in Commissioner's Order. Language of this legislation identifies the remaining 18 Commissioner's Orders and extends their expiration date to September 1, 1993. It also places a proposed rule, to be published in the Minnesota State Register in late April, into permanent rule without further administrative action. Finally, it grants emergency rule making authority for certain sections in the bill.

The language of the proposed rule contains no substantial change from language that was previously promulgated, in accordance with statutory requirements, by commissioner's order. This language, as listed later in this document, has clear and specific statutory authority for rulemaking. Language existing in commissioner's orders that does not have clear and specific statutory authority for rulemaking was set aside and will be promulgated by emergency rule after this legislation passes. Once the language of the emergency rules are effective, the department will begin the process of promulgating those provisions into permanent rule through the Administrative Procedure Act. With the language of the proposed rule codified into permanent rule and the promulgation of the emergency rules, there will be no substantial change in the department's management and regulation of programs and resources previously covered by commissioner's order.

Part 2. Need For 1993 Commissioner's Order Legislation.

The 1993 commissioner's order legislation is necessary because the 1991 legislation states that commissioner's orders that have not been subjected to the Administrative Procedure Act expire on July 1, 1993. If this legislation does not pass, the state's game and fish resources will be at risk due to lack of regulatory protection. Emergency action would have to be taken to restore or extend the use of commissioner's order and the department would be forced to promulgate language, that was previously and correctly promulgated through an existing statutory process, through the Administrative Procedure Act. Furthermore, this would place the Game & Fish Fund at a tremendous financial risk by having to fund an extremely complex and assumably expensive public hearing The most important aspect of this process is that "THE LANGUAGE OF THE PROPOSED RULE AND THE LANGUAGE OF THE LEGISLATION AND ASSOCIATED EMERGENCY RULES MAKE NO SUBSTANTIAL CHANGES TO THE CURRENT REGULATION AND MANAGEMENT OF MINNESOTA'S GAME AND FISH RESOURCES'.

SECTION 2. REASONABLENESS.

Part 1. Outline Of Commissioner's Order Project.

Upon passage of the initial legislation in 1991, the department appointed a team to review the existing commissioner's orders and to act upon the requirements resulting from the legislation. consisted of representatives from Fish & Wildlife Administration, Section of Wildlife, Section of Fisheries, Division of Enforcement, and Attorney General's Office. Administrative oversight was provided by the Assistant Commissioner for Human Resources and Special Programs. The workings of this team and their efforts was coordinated by:

From the time of conception through May of 1992, the team reviewed the language of existing commissioner's orders and developed a document that consolidated a revised version of these documents, except for those relating to experimental management waters which were not included. This consolidated document was promulgated as Commissioner's Order Number 2450 and was published in the State Register on June 22, 1992. Upon the promulgation of that order, the team began review of its language for further revision and preparation, by development of a proposed rule, for action by the 1993 legislature. During this review, the team separated the language into five categories:

- a) Language that had specific statutory authority for rulemaking which would be included in the proposed rule.
- b) Repeat of statutory language which, once identified, would be deleted.
- c) Commissioner's Order language that has existed for several years that would be deleted from the proposed rule and placed directly into statute.
- d) Language that is no longer needed and would be deleted from the proposed rule.
- e) Language that does not have clear and specific statutory authority for rulemaking which, once identified, would be deleted from the proposed rule and placed into a proposed emergency rule. Language authorizing rulemaking, including emergency rules, for these provisions would be included in the 1993 legislation.

Once this review was completed and all necessary information was compiled, the team meet with the authors of the legislation to develop the language of the bill. In April of 1993, the department will publish the proposed rule in the in State Register. It is the intent of the department that, once the legislation passes, the aforementioned emergency rules will be promulgated so that the comprehensive set of game and fish regulations is restored. This will ensure that the resource and management programs are not at

risk from lack of regulatory protection. Once promulgated, the language of the emergency rules would then be promulgated as proposed permanent rules through use of the Administrative Procedure Act.

 - g) No. 2303 Experimental Regulations For The Taking And Possession Of Walleye And Largemouth Bass In Waconia Lake, Carver County;

Part 3. Standard Of No Substantial Change.

Throughout the Commissioner's Order Project, the department has maintained a standard of no substantial change. This means that,

when the language of Commissioner's Order Number 2450 was developed, no substantial change from existing commissioner's order language was made. If a substantial change had to be made, the change was promulgated as a separate commissioner's order prior to the promulgation of Commissioner's Order Number 2450. Similarly, the language of the proposed game and fish rules contains no substantial change from existing commissioner's order language. It is simply a codification, into permanent rule, of existing commissioner's order language that was promulgated under a statutorily defined process.

Part 5. Required Statements.

a) Small Business Considerations.

The language of the proposed game and fish rules is only a codification of existing commissioner's order language and no substantial changes were made, therefore, there is no change in the impact of small businesses in this state.

b) Estimated Costs To Local Public Bodies.

The language of the proposed game and fish rules is only a codification of existing commissioner's order language and no substantial changes were made, therefore, there is no change in the total cost to public bodies and the requirements of Minnesota Statutes, section 14.11 are not applicable.

The language of the proposed game and fish rules is only a codification of existing commissioner's order language and no substantial changes were made, therefore, any fees contained in this language have previously existed.

d) Effects On Agriculture Land.

The language of the proposed game and fish rules is only a codification of existing commissioner's order language and no substantial changes were made, therefore, there is no change in the effects on agriculture land.
