CHARTER AMENDMENT #13

Shall the proposed Amendment to the Charter, which proposed amendment amends Chapter 7 thereof by amending Section 72, be ratified and adopted?  
The Amendment is As Follows:

Section 72-B Bonded Debt and Limit. No bond shall ever be issued to pay current expenses or to refund certificates of indebtedness issued to provide for temporary deficiencies in the revenues to cover current expenses, but bonds may be issued by a four-fifths vote of the council, subject to the referendum powers of the people, for the purchase of real estate, for new construction, for new equipment and for all improvements of a lasting character. The total bonded debt of the city shall never exceed 10 per cent of the assessed valuation of all the taxable property in the city, but in computing the total bonded debt, emergency debt certificates, and bonds issued prior to the adoption of this charter and either held in a sinking fund or issued for the purchase, construction, maintenance, extension enlargement, or improvement of water, or other public convenience from which a revenue is or may be derived, owned and operated by such city or village, or the acquisition of property needed in connection therewith, or for the improvement of streets, parks or other public improvements, to the extent that they are payable from the proceeds of assessments levied upon property especially benefitted thereby, and obligations issued for the improvements which are payable
